#### Land Acquisition Act (Chapter 460)

Notification under Section 7

*My No.:* RUW/LAN/AQUTN/A2/57.  
*Land Ministry's Ref No.:* 4-3/9/2017/Z/WS/83.

I hereby give notice under Sub-section (1) of Section 7 of Land Acquisition Act as amended by Land Acquisition (Amendment) Act No. 28 of 1964 that government intends to acquire the following land/servitude which are required for a public purpose.

*Public Purpose:* Acquisition of allotment are for construction of access road for water storage tank with a capacity of 450 m<sup>3</sup> in Large water scheme in Ruwanwella in Divisional Secretary's Division of Ruwanwella.
