I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land / servitude which is required for a public purpose.

Description of the land or servitude to be acquired:

An allotment of land is called Nikatenna waththa about 0.0202 hectares in extent is depicted as Lot 01, in preliminary plan Number P.P.K 3742 and dated 17/12/2019 made by the Senior Survey Superintendent and situated in the Village of Walimanna, in the Grama Niladari Division of No. 43 B, Gataberikantha, in the Minor Division of Galbadakorale (West), in the Divisional Secretariat Division of Aranayaka, in the District of Kegalle, in Sabaragamuwa Province. Boundaries are as follows.
