THE order under Sub section 3(1) that has to be read with sub Section 4(1) of the Forest Conservation Ordinance (Chapter 451) No. 16 of 1907, as amended by Act No. 13 of 1966 (reprint), No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009.

By virtue of the powers vested in me under Sub section 3(1) that has to be read with Sub section 4(1) of the Forest Conservation Ordinance (Chapter 451) No. 16 of 1907, as amended by Act No. 13 of 1966 (reprint), No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009, I, Minister of Wildlife and Forest Resources Conservation do by this Order declare the state lands of the extent 63.0 hectares bounded by the limits set forth in the Schedule hereto as Galkadawala Reserved Forest from 07th day of August, 2024.
