# Land Acquisition Notices

## THE LAND ACQUISITION ACT (CHAPTER 460) Notice under Section 7

*My No.*: WGSWD&EIP/ACQ/KB/33. *Tourism & Lands Min's Ref No.*: 4/3/10/2016/LRB/67.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the State has acquired the land located adjacent to Karadiyana Waste Recycling Centre and Weras Ganga, to maintain a water retention area and resettle the persons those who were displaced due to this project under Weras Ganga Storm Water Drainage and Environment Improvement project.

### Description of the land to be acquired :
