Description of the Land. - The allotment of land depicted in the Advance Tracing No. Maha/HRS/2022/122 dated 16.11.2022 prepared by the Surveyor General, situated in the Village called Kurunduwatta in No. 456, Kurunduwatta Grama Niladhari Division, in Kurulugammanna Siyapattuwa Minor Division in the Divisional Secretary's Division Harispattuwa in Kandy District of Central Province and bounded as follows.
