I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act No. 28 of 1964 that the Government intends to acquire the following lands which are required for a public purpose:

Description of the lands to be acquired:

Public purpose means to acquire lands for the construction of the Lower Malwathu Oya Reservoir.
