THE LAND ACQUISITION ACT (CHAPTER 460)

Notice Under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude which are required for the public purpose mentioned below.

The servitude of the land lots depicted as Lot No. 01, 02, 03 in Paper 01 of Zone 02 in Cadastral Plan bearing No. 820049 situated in the Village of Hungangoda in Grama Niladhari Division of No. 427, Nawimana South in the Divisional Secretary's Division of Matara Four Gravets, Matara District, Southern Province was acquired for constructing as access road to the land where the salt barrier is being built under Stage IV Water Supply Scheme Matara.
