ORDERS under the Co - operative Employee's Pension Statute No. 02 of 2019 of the Southern Provincial Council

AS the Southern Provincial Council has been dissolved, the powers vested upon the Minister in charge of the subject under section 24 of the Co - operative employee's pension statute No. 02 of 2019 of the Southern Province Provincial Council, have been assigned to me, the Governor of the Southern Province by Article 154(C) of the Constitution of the Democratic Socialist Republic of Sri Lanka and in terms of such powers, I do hereby repeal order 03 and substitute it with the following order under the Co - operative Employee's Pension Statute No. 02 of 2019 of the Southern Province Provincial Council and the said set of orders are amended and enacted. These orders shall be effective from 17.07.2020.

03. (i)

- (a) Any person who has been in service on the date of this scheme coming into operation and is entitled to join the scheme, should intimate his willingness to contribute to the pension scheme on or before 31.12.2023.
- (b) Any employee entitled to join the scheme shall, for the purpose of joining the scheme, complete the application prescribed for the purpose by the Director of the scheme (hereinafter referred to as the "Director") and shall submit to the authorized official within the period from date of these orders coming to operation until 31.12.2025.

(ii)

- (a) Any employee who has exceeded 90 days since the date of appointment to the permanent service after the date of this scheme coming into operation and prior to coming into effect of these orders, shall complete the application prescribed for the purpose by the Director of the scheme and shall submit it to the official authorized by the Director within the period until 31.12.2025.
- (b) Any employee who has not exceeded 90 days since the date of appointment to the permanent service after the date of this scheme coming into operation and prior to coming into effect of these orders, shall complete the application prescribed for the purpose by the Director of the scheme and shall submit it to the official authorized by the Director within the period of 90 days from the date of issuance of the letter of confirmation of service by the relevant Co - operative society.
- (iii) Any employee who joins the scheme since the date of these orders coming into effect, shall complete the application prescribed for the purpose by the Director of the scheme and shall submit it to the official authorized by the Director within the period of 90 days from the date of issuance of the letter of confirmation of service by the relevant Co - operative Society.
