Value Added Tax Act, No. 14 of 2002

Regulation under Section 6

BY virtue of the powers vested in me under Section 6 of the Value Added Tax Act, No. 14 of 2002 as amended by the Value Added Tax (Amendment) Act, No. 19 of 2019, I, Anura Kumara Disanayake, Minister of Finance, Planning and Economic Development of the Democratic Socialist Republic of Sri Lanka, do by this regulation prescribe that, the value of goods imported and specified in the Column I, II and III of the Schedule hereto, shall be determined in the manner specified in the corresponding entry in Column IV of the Schedule hereto.

This Notice shall come into effect from the first day of the month immediately succeeding the month in which this Notification is approved by Parliament.
