Ports and Airports Development Levy Act, No. 18 of 2011

#### Order under Section 3

BY virtue of the powers vested in me by Sub-section (3) of Section 3 of the Ports and Airports Development Levy Act, No. 18 of 2011, I, Anura Kumara Disanayake, Minister of Finance, Planning and Economic Development of the Democratic Socialist Republic of Sri Lanka, do hereby, amend the Schedule IV of the Order published in the *Extraordinary Gazette* Notification No. 2312/67 dated December 31, 2022 as last amended by the *Extraordinary Gazette* Notification No. 2364/37 dated December 31, 2023 by deletion of the article specified in Column III corresponding to the H.S. Code 7103.10 specified in the Column II and the corresponding entry in Column IV thereto, and the addition of the articles specified in Column III corresponding to the H.S. Heading and H.S. Codes specified in the Column I and II as exempted in Column IV of the Schedule hereto.

This Order shall come in to effect from November 08, 2025.
