Regulations

The Motor Traffic (Driving Licence Levy) Regulations, No. 03 of 2022 published in *Gazette Extraordinary* No. 2301/17 of October 10, 2022 are hereby amended, in Schedule I thereto, as follows: -

- (1) In item 12 thereof, by the repeal of the entries in Column I, Column II and Column III and the substitution therefor, of the following entries: -



<i>“Column I</i>	<i>Column II</i>	<i>Column III</i>
12. (a) Issuing a Driving Licence to a citizen of Sri Lanka who is the holder of a driving licence or any equivalent thereof, which has been issued outside sri Lanka	30,000.00	30,000.00
(b) Issuing a Driving Licence to a person other than a citizen of Sri Lanka who is the holder of a driving licence or any equivalent thereof, which has been issued outside sri Lanka	60,000.00	60,000.00”;

- (2) In item 13 thereof, by the repeal of the entries in Colomn I, Colomn II and Colomn III and the substitution therefor, of the following entries: -

<i>“Column I</i>	<i>Column II</i>	<i>Column III</i>
13. (a) Issuing a Driving Licence to a person other than a citizen of sri Lanka	45,000.00	45,000.00
(b) Renewal of Driving Licence issued to a person other than a citizen of sri Lanka	15,000.00	15,000.00
(c) Issuing a duplicate of a Driving Licence to a person other than a citizen of sri Lanka whose Driving Licence has been destroyed, defaced or damaged	15,000.00	15,000.00
(d) Issuing a duplicate of a Driving Licence to a person other than a citizen of sri Lanka whose Driving Licence has been lost	30,000.00	30,000.00”;

- (3) In item 14 thereof, by repeal of the entries in Colomn I, Colomn II and Colomn III and the substitution therefor, of the following entries: -

14 (a) Issuing a temporary Driving Licence to a visitor other than a citizen of Sri Lanka		
(i) for a period of one month	15,000.00	15,000.00
(ii) for a period of more than one month and up to two months	21,000.00	21,000.00
(iii) for a period of more than two month and up to six months	30,000.00	30,000.00
(iv) for a period of more than six month and up to a period of twelve months	45,000.00	45,000.00
(b) Issuing a temporary Driving Licence to a visitor who is a citizen of Sri Lanka		
(i) for a period of three months	15,000.00	15,000.00
(ii) for a period of more than three months and up to six months	18,000.00	18,000.00
(iii) for a period of more than six months and up to twelve months	24,000.00	24,000.00”.
