#### THE LAND ACQUISITION ACT

(CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation hereby declare under Sub section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land stated below, depicted in the Advance Tracing No. KU/WRY/2021/407 dated 09.12.2021, prepared by the Surveyor General, situated at the Village of Ipalawa, in Ipalawa Grama Niladhari Division, No. 1249, in the Divisional Secretary's Division of Wariyapola, in Kurunegala District, North Western Province and bounded as follows.
