THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

BY virtue of Sub-section (1) of Section 5 of the Land Acquisition Act, I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, do hereby declare that the lands specified below are required for a public purpose and will be acquired under the provisions of the Land Acquisition Act.
