I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act that the Government has acquired the allotments of the land located between Rajamaha Vihara Road, Nawinna, Maharagama and Egodawaththa Road Boralesgamuwa are required for canal development in the paddy field, creating a water tank, water reserve and townscape development under Weras Ganga Storm Water Drainage and Environment Improvement Project.
