## **THE LAND ACQUISITION ACT (CHAPTER 460)**

### Notice under Section 7

I hereby give notice, under Sub Section (1) of Section 7 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/ Servitude which is required for KM/AK/AL - Arham Vidyalaya, Addalaichanai.

Description of the land or servitude to be acquired :
