#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of below mentioned lands depicted in the Advanced Tracing No. GA/WAT/2020/290 dated 26.06.2023, prepared by the Surveyor General, situated in the Village called Elapitiwala in the Grama Niladhari Division No. 179-Elapitiwala in the Divisional Secretary's Division of Wattala in Gampaha District of Western Province and bounded as follows:

#### 1. Lot 'A1' - Extent: 0.2685 Hectare
