PART I : SECTION (I) — GENERAL Government Notifications

Excise (Special Provisions) Act, No.13 of 1989

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989, as amended, I, Anura Kumara Dissanayake, Minister of Finance, Planning and Economic Development do by this Order amend the Order published in the Extraordinary *Gazette* Notification No. 2418/43 dated January 10, 2025, as last amended by the Extraordinary *Gazette* Notification No. 2421/42 dated January 31, 2025, as follows:

- 1. repeal of HS Codes 8703.80.71 and 8703.80.72 specified in Column II and the corresponding articles specified in Columns III and IV of the Schedule thereto; and
- 2. addition of the rate of Excise duty specified in the Column IV applicable on corresponding articles specified in Column I, II and III of the Schedule hereto.

This Order shall come into effect from April 29, 2025.
