#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, do hereby declare, under Subsection (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

THE allotments of land described as following names and extents depicted in the Advanced Tracing No. Maha/MDD/2021/685 dated 27.05.2022 prepared by the Surveyor General, situated at the Village of Burnside, in No. 795 Burnside Grama Niladhari Division, in Palispattuwa Korale North minor division, in the Divisional Secretary's Division of Medadumbara in Kandy District, Central Province and bounded as follows:

# 01. Lot 'A' - Burniside Estate - Extent: 13.4952 Hectares
