##### THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964 that the Government intends to acquire the following lands/servitudes which are required for a public purpose.

##### *Description of the land or servitude to be acquired:*
