##### Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below is needed for a public purpose and will be acquired under the provisions of that Act.

### Declaration under Section 5
