THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

- I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, hereby declare, under Subsection (1) of Section 5 of the Land Acquisition Act, that the servitudes described in Paragraph 01 below are needed for a public purpose and will be acquired under the provisions of that Act. Paragraph 02 describes the land from which the servitude is acquired.
- 01. **Description of the Servitude.** Acquisition of servitude right over the allotments of land for widening of access road to the water treatment plant of Bingiriya Udubaddawa and Makandura Pannala Kuliyapitiya Water Supply Project.
