#### CIVIL AVIATION AUTHORITY OF SRI LANKA ACT, No. 34 OF 2002

#### Order under section 9

BY virtue of the powers vested in me by section 9 of the Civil Aviation Authority of Sri Lanka Act, No. 34 of 2002, I, Bimal Niroshan Rathnayaka, Minister of Transport, Highways, Ports and Civil Aviation, do by this Order amend the Schedule to the Order published in the *Gazette Extraordinary*, No.2050/38 dated December 21, 2017, under the heading "AERONAUTICAL FACILITIES AND LAND APPERTAINING THERETO (SPECIFIED IN THE THIRD SCHEDULE)" as follows: -
