#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Kuragama Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, do hereby declare under Sub section (1) of Section 5 of the Land Acquisition Act, that the lands mentioned below are needed for a public purpose and will be acquired under the provisions of that Act.
