I, do hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude which is required for a public purpose (Acquisition of land for construction of C. V. 220/132 Gripe Substation under the Power System Reliability Strengthening Project).
