THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, amended by Land Acquisition (Amendment) Act No. 28 of 1964, that the servitude described in Column I below is needed for a public purpose and will be acquired under the provisions of that Act, Column II describes the Land from which the said servitude is acquired.

I. Description of the servitude.– Acquisition of servitude right over the allotments of land for the laying of distribution pipelines from the Yahalathenna Service Reservoir to the Aladeniya - Muruthalawa Main Road under Kandy North Pathadumbara Intergrated Water Supply Project.

II. Description of the Land.– The allotments of land defined as following names and extents, depicted in the Advance Tracing Maha/HRS/2022/122 dated 16.11.2022, prepared by the Surveyor General, situated at the Village of Kurunduwatta, in Kurunduwatta Grama Niladhari Division, No. 456, in Kulugammana Siyapattuwa Minor Division, in the Divisional Secretary's Division of Harispattuwa, in Kandy District, Central Province and bounded as follows:
