THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragama Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of Land, depicted in Advance Tracing No. B/LNG/2005/347 dated 23.11.2005, prepared by the Surveyor - General, Situated in the Village of Yapamma Udagama, in the Hopton Grama Niladhari Division, of the Pattipola Korale Minor Division, in the Lunugala Divisional Secretary's Division, Badulla District, Uva Province and bounded as follows:

01. Lot A - Hopton watta (Field No. 6 - Bangala watta) - Extent: 0.0304 Hectare

North: Hopton watta (Field No. 6 - Bangala watta); East: Hopton watta (Field No. 6 - Bangala watta) and Estate Road; South and West: Hopton watta (Field No. 6 - Bangala watta).

02. Lot B - Hopton watta (Field No. 6 - Bangala watta) - Extent: 0.0548 Hectare

North: Estate Road; East: Estate Road and Road (Road Development Authority); South: Road (Road Development Authority) and Hopton watta (Field No. 6 - Bangala watta) ; West: Hopton watta (Field No. 6 - Bangala watta) and Estate Road.

03. Lot C - Hopton watta (Field No. 8 - Bangala watta) - Extent: 0.0014 Hectare

North: Hopton watta (Field No. 8 - Bangala watta) and Estate Road; East and South: Estate Road; West: Hopton watta (Field No. 8 - Bangala watta).
