THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land depicted in below names and extents in Advance Tracing No. CO/DSO/2025/215 dated 28.08.2025 prepared by the Surveyor General situated in the Villages of Angoda, Mulleriyawa (Ward No. 11 - Mulleriyawa, within the Kotikawatta-Mulleriyawa Pradeshiya Sabha limits) in the Grama Niladhari Division 503A of Mulleriyawa South in the Divisional Secretary's Division of Kolonnawa in Colombo District of the Western Province and bounded as follows:
