GRANTING PERMISSION BY VIRTUE OF POWERS VESTED IN ME UNDER SECTION 27(A) OF PROVINCIAL COUNCIL ACT No. 42 OF 1987 AS THE TERM OF THE SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ENDED ON 26TH SEPTEMBER, 2017.

**2025**

1. This permission may be cited as “Permission to disburse under the Seventh supplementary financial statement - 2025 of the Sabaragamuwa Provincial Council” and come in to operation from 31 .12.2025.

2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Sixty Five Billion Six Hundred Twenty Three Million One Hundred Six Thousand Nine Hundred Seventy Five and Sixteen Cents only (65,623,106,975.16) for the service of the period beginning on 01st of January, 2025 and ending 31st December 2025, which is specified as “Financial Year 2025” in the Annual Financial Statement and Revenue and Expenditure Estimate for 2025 approved on 03.04.2025, as amended by the First, Second, Third, Fourth, Fifth and Sixth Supplementary Estimates for 2025, is hereby amended as, Rupees Sixty-Five Billion Six Hundred Thirty-Three Million Three Hundred Seventy-Seven Thousand Forty - Eight and Cents Seventy-Two (Rs. 65,633,377,048.72) and grant permission to the Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.

3. Accordingly the first schedule of the Annual financial statement and revenue expenditure estimates-2025, is amended as the first schedule here of and grant permission to disburse the same.
