**Statement of Accounting Policies
31st December, 2005**

(a) Basic of Accounting

Financial Statement are prepared on the historical cost basis of accounting whereby the transactions are recorded at a value prevailing at the dates when the assets were acquired the liabilities were incurred and funds received in accordance with generally accepted accounting principles and accounting standards laid down by the Institute of Chartered Accountants of Sri Lanka.

(b) Revenue

(i) Grants

All Government grants pertaining to capital and recurrent recognized at the time of allocation.

(ii) Course Fee

Course fee charged from students are recognized as income at the time of collection.

(iii) Investment Income

Investment Income is recognized on a time proportion basis.

(iv) Specific Grants receive during the year credited to University income.

(c) Valuation of Assets

Building, Equipment and Furniture

All assets are recorded at cost of purchase with incidental expenses. Assets received as donations have been valued at their cost. Assets for which the dates of purchased are known, depreciation is provided proportion to the No. of months completed or such assets were used from the date of purchase.

Assets for which the exact date of payment is not known, depreciation is provided from the date on which entered into the Inventory (Library Books).

Depreciation in provided each year at the following rates on a straight-line basis.

Buildings	- 05%
Furniture	- 10%
Office Equipment	- 20%
Library Books	- 20%
Motor Vehicle	- 20%
Laboratory & Teaching Equipment	- 20%
Cloaks	- 20%

(d) Inventories

Stocks

Stocks of stationery and other miscellaneous stock are valued at cost of purchase.

Stocks of course materials as at 31st December, 2005 are valued at minimum printing cost of such books after physical verification and brought to books by crediting General Reserve.

(e) On the advice of Auditors, balances of specific funds transferred to General Reserve.

(f) Donations

Donations are recognized as income over the useful life of the assets.

Audit Opinion

Audit of accounts of the Open University of Sri Lanka for the year ended 31st December, 2005 were carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 108 (1) and III of the Universities Act, No. 16 of 1978 and Sub-Section (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971.

Except of the effects on the financial statements of the matters referred to in para 2 : 2 of my report, I am of opinion so far as appears from my examination and to the best of my information and according to the explanation given to me the financial statement have been prepared and presented in accordance with the Sri Lanka Accounting Standards and stated accounting policies as set out in Notes (form Note (a) to (f)) to the financial statements and give a true and fair view of the financial position of the University as at 31st December, 2005 and the financial results and cash flow for the year then ended.
