01. Significant Accounting Policies

1. General

The Fixed Assests are shown at cost less accumulated depreciation. Depreciation is charged on straight line method at the following rates per annum.

Fixtures and Fittings	10%

Library Books and Periodicals	20%
Lab Tools	20%

Depreciation is not charged in the year of purchase whilst a full year's depreciation in charged in the year of disposal.

3. Provision for Gratuity

Full provision is made in the accounts for the retiring gratuity for all employees completed five years of service.

4. Income and Expenditure

- 4.1 Revenue Recognition
 - (a) Revenue and enrolment fees from students are accounted on cash basis whilst interest income is accounted an accrual basis.
 - (b) Income from Specific Funds and Endowment

Donations, income from research grants and other services rendered are included to the extent of the completion of the service concerned. This is generally equivalent the sum of the relevant expenditure during the year.

5. The Institute of Biochemistry, Molecular Biology and Biotechnology Building and Assets purchased from the financial assistance (Soft Loan) of SEK. 15.m (Rs.180m) is shown in the books of University of Colombo (Borrower on behalf of Government of Sri Lanka).
