#### (a) Basis of Accounting

#### (b) Revenue

##### (i) Grants :

All Government grants pertaining to capital and recurrent recognized at the time of allocation.

##### (ii) Course Fee :

Course fee charged from students are recognized as income at the time of collection.

##### (iii) Investment Income :

Investment Income is recognized on a time proportion basis.

(c) *Valuation of Assets :*

All assets are recorded at cost of purchase with incidental expenses. Assets received as donations have been valued at their cost.

(d) *Depreciation of Non Current Assets :*

Non Current assets are shown at cost less accumulated Depreciation. Depreciation is charged on straight line method at the following rates per annum in order to write off the cost of such assets over their estimated useful lives.

Depreciation is not charged in the year of purchased whilst a full years depreciation is charged in the year of disposal.

Donations are recognized as income over the useful life of the assets.

(g) *Provision for Gratuity :*

Full provision is made in the accounts for the retiring gratuity payable to the all employees from the year which they completed the 5 years in the service. This provision is not externally funded.
