1. This is the Report on the financial affairs of the University of Kelaniya for the year 2007 in terms of the Universities Act No.16 of 1978.

3. Outcome of the Recurrent Services of the year

## (I) Income

The Government grant for the recurrent expenditure for the year 2007 was Rupees Eight hundred and Thirty- four Million Six Hundred and Four Thousand (Rs. 834,604,000). Government grant received under capital expenditure vote 101 rehabilitation and maintenance services was Rupees Six Million Five Hundred and Three Thousand Nine Hundred and Ten (Rs. 6,503,910). In addition, income from other recurrent sources was Rupees One Hundred and Sixty Million Three Hundred and Six Thousand One Hundred and Sixty-five (Rs. 160,306,165). Accordingly, the total recurrent income for the year 2007 was Rupees One Thousand and One Million Four Hundred and Fourteen Thousand and Seventy-five (Rs. 1,001,414,075).

## (II) Expenditure

The total recurrent expenditure for the year was Rupees one Thousand and Thirty-two Million Eight Hundred and Ten Thousand Two Hundred and Seventy-eight (Rs. 1,032,810,278). The expenditure for the rehabilitation and maintenance services was Rupees Six Million Five Hundred and Three Thousand Nine Hundred and Ten (Rs. 6,503,910). Accordingly, the total expenditure was Rupees One Thousand and Ninety-one Million Four Hundred and Sixty Thousand One Hundred and Eighty-seven (Rs. 1,091,460,187) inclusive of the expenditure of fee-levying courses. The amount allocated for the depreciation for the year 2007 was Rupees Ninety- one Million Forty-eight Thousand Five Hundred and Ninety-eight (Rs. 91,048,598). Accordingly, the recurrent expenditure for the year 2007 was Rupees Nine Hundred and Ninety-three Million Nine Hundred and Seven Thousand Six Hundred and Seventy- nine. (Rs. 993,907,679).

## (III) Utilization of Accounting impact and allocations

The excess of expenditure over income, after consideration of the total income and expenditure including the depreciation was Rupees One Hundred and Thirty-four Million Two Hundred and Eighty-six Thousand Nine Hundred Seventy-eight (Rs. 134,286,978).

## (IV) Expenditure for Hostel Facilities

The income received from hostels in 2007 was Rupees One Million Ninety-six Thousand Seven Hundred and Thirty-seven (Rs.1,096,737) while the expenditure was Rupees Sixteen Million Three Hundred and Thirty-five Thousand and Seventy-two (Rs. 16,335,072). The additional expenditure of Rupees Fifteen Million Two Hundred and Thirty-eight Thousand Three Hundred Thirty-five (Rs. 15,238,335) incurred for providing hostel facilities was financed by the other income.

(V) Expenditure for Centre for Open and Distance Learning

The income received from the activities related to Centre for Open and Distance Learning was Rupees Thirty-nine Million Three Hundred and Four Thousand Two Hundred and Forty-five (Rs. 39,304,245) and the expenditure was Rupees Forty-five Million Six Hundred and Fifty-five Thousand Three Hundred and Ninety-three (Rs. 45,655,393). However, the expenses of Rupees Six Million Three Hundred and Fifty One Thousand One Hundred and Forty-eight (Rs. 6,351,148) for electricity, water, rentals for buildings and charges for other maintenance services were included in this expenditure.

(VI) Over and under provision account

With the under-provision carried forward from the last year, after adjusting the last year transactions, the aggregate amount brought forward is Rupees Eight Hundred and Fifty-six Million Nine Hundred and Thirty-one Thousand Four Hundred and Seventy-three (Rs. 856,931,473).

4. Output of the capital services

(I) Expenditure Vote 101– Rehabilitation and Maintenance services

The estimated Government capital grant for expenditure vote 101 for the year was Rupees Thirty-two Million (Rs. 32,000,000) while the expenditure inclusive of the adjustments for the last year was Rupees Thirty-one Million Two Hundred and Thirty-nine Thousand Two Hundred and Forty-five (Rs. 31,239,245). From this expenditure, Rupees Six Million Five Hundred and Three Thousand Nine Hundred and Ten (Rs. 6,503,910) was recurrent expenditure while Rupees Twenty-four Million Seven Hundred and Thirty-five Thousand Three Hundred and Thirty-six (Rs. 24,735,336) was capital expenditure.

(II) Expenditure Vote 102 – Laboratory and teaching equipments, books and journals

The estimated Government capital grant for the year was Rupees Sixty Million Five Hundred Thousand (Rs. 60,500,000). The expenditure for the year with the adjustments related to past years was Rupees Eighty-six Million Five Hundred and Seventy-eight Thousand Four Hundred and Six (Rs. 86,578,406). In addition, the expenditure for advance payments was Rupees Seven Million Three Hundred and Seventy One Thousand-one Hundred and Forty-two (Rs. 7,371,142).

(III) Expenditure Vote 103 – Constructions

The estimated Government grant for the year was Rupees Eighty-five Million (Rs. 85,000,000). Expenditure for the year with the adjustments related to past year was Rupees Seventy-nine Million Three Hundred and Fifty thousand Five Hundred and Forty-six (Rs. 79,350,546).

5. Analysis of recurrent expenditure

In the analysis of recurrent expenditure for the year 2007, it was revealed that of the total expenditure, 19.50% has been spent for General Administration (45.16% of this was for depreciation of fixed assets), 62.85% for Academic Activities, 2.45% for Library Services, 3.03% for welfare activities, 6.16% for maintenance of lands and buildings, 4.42% for centre for open and distance learning and 1.59% for student hostel facilities.

6. Analysis of cost per student

Total number of registered students for the year 2007 was 7986. The direct and indirect costs per student in each faculty from year 2002 to year 2007 are as follows:
