## Notes to the Financial Statements

### 1. Significant Accounting Policies

#### 1.1 Reporting Entity:

The Institute of Chartered Accountants of Sri Lanka (hereinafter referred to as the 'Institute') which is situated at No. 30A, Malalasekera Mawatha, Colombo 7 was incorporated by Act, of Parliament, No. 23 of 1959.

#### 1.2 Basis of Preparation :

The Financial Statements have been prepared in accordance with the Sri Lanka Accounting Standards (SLAS) and are based on historical costs and do not take into account changing money values, except where stated. Cost is based on the fair values of the consideration given in exchange for assets. The accounting policies are consistent with those used in the previous year. The Financial Statements were authorised for issue by the Council on 30th March, 2009.

The Financial Statements are presented in Sri Lanka Rupees, which is the functional and presentation currency. Figures and phrases relating to the previous year have been restated where necessary, to conform to the current year's presentation.

The preparation of Financial Statements in conformity with SLAS requires management to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimated assumptions are based on historical experience and various factors that are believed to be reasonable under the circumstance, the result of which forms the basis of making the judgements, Actual results may differ from estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised, if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

### 1.3 *Assets and the Bases of their Valuation :*

#### 1.3.1 Property, Plant and Equipment

Property, Plant and Equipment are stated at cost, less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset. Depreciation is charged to the Income Statement on the written-down values at the following rates per annum in order to write-off the cost of such assets over their estimated useful lives, except in the case of Buildings on Leasehold Land. Buildings on Leasehold Land have been depreciated over the shorter of the lease term and their estimated useful lives :

As per SLAS 18 (Revised) - Property, Plant and Equipment, depreciation has been provided from the date an item of Property, Plant and Equipment is available to use.

#### 1.3.2 Educational Material - IRQUE Project

Library books purchased under the IRQUE Project is capitalised and charged to the Income Statement over a period of 3 years.

Work-Based Learning Programme being a software purchased from the Institute of Chartered Accountants in England and Wales (ICAEW) is charged to the Income Statement over a period of 4 years.

Multimedia English Learning Centre (MELC) software used to enhance the English communication knowledge of the students, will be written-off over the period of 4 years.

Syllabus Development Cost represents the cost incurred to develop Business Communication I and II syllabuses and will be written-off over a period of 3 years.

#### 1.3.3 Inventories

Inventories held for sale are stated at the lower of cost and net realisable value after making due allowances for obsolete and slow-moving items. Cost is arrived at on a weighted average basis.

Other inventory items are stated at the lower of cost and net replacement cost.

#### 1.3.4 Receivables

Receivables are recognised and carried at original invoice amount, less any allowance for any uncollectible amounts. An estimate for doubtful debts is made when collection of the full amount is no longer probable.

#### 1.3.5 Short-term Investments

Treasury Bills are valued at cost plus accrued interest. Other short-term investments are valued at the lower of cost or market value.

#### 1.3.6 Cash and Cash Equivalents

Cash and cash equivalents comprise cash on hand and deposits at Bank. Bank overdraft is included as a component of cash and cash equivalents for the purpose of the Statement of Cash Flows.

### 1.3.7 Cash Flow Statement

Cash flow statement has been prepared using the ‘indirect method’.

### 1.4 *Accounting for Grants :*

Grants that compensate the Institute for expenses incurred are recognised as revenue in the Income Statement on a systematic basis in the same period in which the expenses are recognised. Grants that compensate the Institute for the cost of an asset are recognised in the Income Statement on a systematic basis over the useful life of the related asset.

### 1.5 *Employee Benefits :*

#### 1.5.1 Provision for Retiring Gratuity

Provision has been made for the retiring gratuity payable from the initial year of service to all employees. However, under the Gratuity Act, No. 12 of 1983, the liability to an employee arises only on completion of 5 years of continued service.

The liability is not externally funded nor is it actuarially valued.

#### 1.5.2 Defined Contribution Plans

Obligations for contributions to Provident and Trust Funds are recognised as an expense in the Income Statement as incurred.

### 1.6 *Current Liabilities*

#### 1.6.1 Current Liabilities

Current liabilities are those which fall due for payment on demand or within one year from the Balance Sheet date. Non-current liabilities will fall due for payment one year or more after the Balance Sheet date.

#### 1.6.2 Taxation

The Institute is exempt from Income Tax under Section 7 (b) (ii) of the Inland Revenue Act, No. 10 of 2006.

### 1.7 *Events after the Balance Sheet Date*

The materiality of events occurring after the Balance Sheet date has been considered and appropriate adjustments, wherever necessary, have been made in the accounts.

### 1.8 *Income and Expenditure*

#### 1.8.1 Revenue Recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to ICASL and that it can be reliably measured :

- (a) Enrolment fees from members and students are recognised as revenue on receipt. The subscription year runs 01st January to 31st December. Only those membership fees and subscription payments that are attributable to the current financial year are recognised as revenue. Fees and subscription payments that relate to future periods are shown in the Balance Sheet as subscriptions and fees in advance under Current Liabilities;
- (b) Fees on examinations, seminars, courses and other educational and members’ activities are recognised as revenue on completion of such activity;
- (c) Interest income is recognised on accrual basis;
- (d) Revenue from grants is recognised when control of the contribution or right to receive the contribution is received;
- (e) Sponsorship of member-related activities is recognised on receipt.

## 1.8.2 Expenditure

- (a) All expenditure incurred in the running of the Institute and in maintaining the capital assets in a state of efficiency has been charged to revenue in arriving at the surplus for the year.
- (b) All expenditure incurred in the acquisition, extension or improvement of assets of a permanent nature in order to carry on or increase the earning capacity of the Institute has been treated as capital expenditure.
- (c) Expenditure on examinations, seminars, courses and other educational and members' activities is recognised in the Income Statement on completion of such activity.

### **Report of the Auditor General on the Financial Statement of the University of Peradeniya for the year ended 31st December 2007 in terms of Section 108(2) of the Universities Act, No. 16 of 1978 and Section 13(7) (a) of the Finance Act, No. 38 of 1971**

THE audit of financial statements of the University of Peradeniya for the year ended 31st December 2007 was carried out under my direction in pursuance of provisions in Article 154(1) of Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 108 and 111 of the Universities Act, No. 16 of 1978 and Sub - Sections (3), (4) and (7) of Section 13 of the Finance Act, No.38 of 1971. This report is issued in terms of Section 108(2) of the Universities Act and Section 13 (7) (a) of the finance Act, No.38 of 1971.

#### 1.2 Responsibility of the Management for the Financial Statements :

Management is responsible for the preparation and fair presentation of these financial statement in accordance with Sri Lanka Accounting standards. This responsibility includes, designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error, selecting an applying appropriate accounting policies and making accounting estimates that are reasonable in the circumstances.

#### 1.3 Scope of Audit and Basis of Opinion :

My responsibility is to express an opinion on these financial statements based on my audit. Audit opinion, comments and findings in this report are based on review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and test were such as to enable as wide and audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards to obtain reasonable assurance as to whether the financial statements are free from material misstatements. The audit includes the examination on test basis of evidence supporting the amounts and disclosures in financial statements and assessments of accounting principles used and significant estimates made by the management in the preparation of financial statements as well as evaluating their overall presentation. I have obtained sufficient information and explanations which to the best of my knowledge and belief were necessary for the purpose of my audit. I therefore believe that my audit provides a reasonable basis for my opinion. Sub-sections (3) and (4) of Section 13 of the Finance Act, No.38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

#### 2. Financial Statements :

##### 2.1. Opinion :

In view of my comments and observations appearing in this report, I am unable to express an opinion on the financial statements of the University of Peradeniya for the year ended 31st December 2007 presented for audit.

##### 2.2 Comments on Financial Statements :

###### 2.2.1 Sri Lanka Accounting Standards :

Non -compliance with Sri Lanka Accounting Standards are shown below.

- (a) A sum of Rs.134,450 payable for Air Tickets to two lecturers had been set-off against the balance of Rs.1,054,426 receivable from the University Grants Commission as at 31st December 2007 contrary to Standard No.03.
- (b) The written down value of the fixed assets at a total cost of Rs.697,775.81 had become zero as at 31st December 2007 and continued to be used without taking action to revalue and to taking into account the values in terms of Standard No.18. No disclosure had been made in respect of the revaluation done during the year 2002.
- (c) Assets to the value of Rs.2,611,266.394 had been purchased as at 31st December 2007 from the Treasury provisions in terms of Standard No.24 and its annual depreciation had been charged against the operating results. Therefore the net value of Treasury Grants as at that date (differed liability) had not been shown in the financial statements. Further the policy of the institution on accounting Treasury grants had not been disclosed in the financial statements.

## 2.2.2 Accounting Policies :

The following observations are made :

- (a) Although it had been stated in Note 8.1 (e) of the financial statements for the year under review that the financial statements are prepared on accrual basis, land canteen and electricity income amounting to Rs.550,880 rates payable amounting to Rs.1,034,562 and capital expenditure of Rs.2,636,198 payable had not been brought to account on accrual basis.
- (b) Depreciation had been provided for the whole year in respect of fixed assets valued at Rs.258,621.191 purchased during 2007 and depreciation had not been provided for the year under review in respect of assets valued at Rs.5,923,845 disposed of contrary to the University Grants Commission Circular No.649 dated 05th October, 1995.

## 2.2.3 Accounting Deficiencies :

The following accounting deficiencies were observed in audit -

## (a) Omissions from the Accounts :

- (i) Hall charges, Library charges and fines amounting to Rs.1,278,018 receivable for the year 2007 from the students and amounts receivable for the previous years had not been computed and brought to account.
- (ii) Adjustments had not been made in the accounts in respect of computer accessories and office equipment valued at Rs.2,817,600 removed from the use at 4 Libraries.
- (iii) Provision had not been made in the accounts in respect of compensation amounting to Rs.485,621 payable to relevant parties in respect of 12 court cases finalized during 2007.
- (iv) Verification of goods had been carried out by the Head of each Section instead of appointing a Board of Survey to carry out the verification. A sample check revealed that the necessary adjustments had not been made in the accounts in respect of 2,133 unsuitable items, shortages of 1,876 items and excesses of 746 items as stated in the verification reports.
- (v) The vehicle valued at Rs.2,150,000 which had been purchased from the Research Fund of the Science Faculty and handed over to the University in writing had not been brought to account.
- (vi) An examination of the files of the Lecturers who had violated agreements revealed that security bonds amounting to Rs.1,503,154 due from 03 Lecturers had not been brought to account and a sum of Rs.1,547,853 receivable from 05 Lecturers and not been included in the financial statements, even though it had been shown in the Ledger Accounts.

## (b) Overstatements and Understatements in the Accounts :

- (i) Deficit aggregating Rs.842,688 occurred due to incurring expenditure over the income in 13 accounts under Research Funds had been adjusted to the surplus of other such accounts resulting in an understatement of the balance of the other Funds Account by a similar amount.
- (ii) Unpaid salaries amounting to Rs.511,131 remained since year 1995 had been removed from the books by crediting the salaries account instead of being credited to the accumulated fund and therefore, the salaries for the year had been understated by a similar amount.
- (iii) Bursaries relating to year 2007 amounting to Rs.196,700 returned by the Bank had been brought to account as bursaries received for year 2008.
- (iv) Mahapola and bursaries amounting to Rs.15,513,300 receivable and lawyers fees amounting to Rs.1,128,700 payable in respect of the year under review had been understated in the accounts.

## (c) Inappropriate Disclosures in the Accounts.

- (i) Goods had been ordered on 23rd May 2001 for a sum of Rs.179,178 and customs duty and other expenses amounting to Rs.21,881 also had been incurred on these goods which had been misplaced. Even though an insurance cover had been obtained for these goods on 20th April 2001 by paying in installment of Rs.1,602 action had not been taken to obtain the claim for goods from the insurance corporation. These goods had continued to be shown in the accounts as goods in transit.
- (ii) A sum of Rs.3,888,500 received by the University in 2007 as interest on staff loans had been brought to account as "Loans Interest Fund" under other funds, instead of being brought to account as income under Income and Expenditure Account.
- (iii) The difference of Rs.13,339,999 between the stock book balances and physical stock balance from year 1995 to 31st December 2007 had been brought to account as stock adjustment under sundry creditors, without being identified and settle the difference.

- iv. Eight Instances were observed at a sample check where administration charges amounting to Rs.1,389,687 charged by the University on External Researches during the year under review had been accounted under Other Funds without being credited to the University Fund.
- v. The balance of Rs.75,848,243 shown in the balance sheet as at 31st December 2006 as the balance of Motor Vehicle Account included a sum of Rs.1,931,000 being the value of 14 condemned and non using vehicles.
- vi. Equipment valued at Rs.3,482,000 purchased during 2005 and 2006 had been inappropriately shown in the accounts as work-in-progress.

#### 2.2.4 Unreconciled Accounts :

The following unreconciled accounts were observed -

- (a) The balance of the unpaid salaries shown in the financial statements as at end of the year under review was Rs.939,200 where as the total of balances shown in the schedules was Rs.295,860 thus showing a difference of Rs.643,340.
- (b) Differences were observed between the balances shown in the Schedules attached to the financial statements and the relevant registers as shown below.

#### 2.2.6 Accounts Receivable and Payable

The following observation are made.

- (a) Payment of Staff Loans.

- i. Although 302 staff loan balances amounting to Rs.13,688,588 had remained unrecovered as at 31st December 2007, these balances had been removed from the Distress Loan Register and from the Accounts.
  - ii. According to the financial statements, the staff loan balance was Rs.93,757,701 as at the end of the year under review, whilst the balance according to the relevant schedules was Rs.94,451,004 thus indicating a difference of Rs.693,303.
  - iii. 58 Staff loan balances amounting to Rs.2,756,588 shown in the accounts had remained outstanding for periods ranging 01 to 07 years.
- (b) Payment of Advances.
- i. The balance of local supplies advances totaling Rs.2,726,621 includes 81 balances of Rs.670,289 older than 06 years, but action had not been taken to settle these advances. Further, 48 balances amounting to Rs.2,021,170 relating to year 2007 also had not been settled.
  - ii. Advances amounting to Rs.642,186, Rs.2,717,813 and Rs.217,261 respectively granted for Reserch and Other Funds, Capital and Voted Services during 1990 to 2006 had not been settled even as at 31st December, 2007.
- (c) Amounts Receivable for Violation of Bonds.
- i. According to the Register submitted for audit, a sum of Rs.80,484,800 was receivable from 167 Lecturers who had violated bonds during 1988 to 2007. Proper action had not been taken to recover these dues.
  - ii. Although it had been informed that money recoverable form 38 Lecturers who had gone abroad violating agreements and security bonds will be recovered from their Provident Funds, the money had not yet been recovered. Further, action had not been taken to recover the value of bonds amounting to Rs.20,841,443 in excess of the balances of the provident fund from the sureties or through legal proceedings.
  - iii. The sum of Rs.7,573,673 recoverable on security bonds could not be recovered as the files of 38 Lecturers who had violated bonds had been misplaced and action had not been taken up to date in respect of the officers responsible.
- (d) Action had not been taken to recover the sum of Rs.127,896 and Rs.1,530,710 respectively recoverable from 08 officers and 09 external institutions for water, electricity and rent.
- (e) Action had not been taken on recover the lease rent amounting to Rs.10,078,200 as at 31st December, 2007 in respect of lease of land to the following 04 institutions.

- (i) Section 5 of Chapter XIX Rent for official quarters had not been recovered from 11 officers from the date of occupying on the year 2007

- (h) Treasury Circular No. 1A1/2002/02 dated 28th November, 2002 of the Secretary to the Treasury Computers valued at Rs.12,877,860 had been purchased during 2007, but the Formats No.02 to 10 had not been obtained from the suppliers and a Register had not been maintained in respect of the said computers.
- (i) Public Administration Circular No.01/2002 of 02nd February, 2002 State emblem had not been printed on 08 vehicles purchased in year 2006 in terms of the said Circular.
- Public Administration Circular No.22/99 dated 08th October, 1999 as amended by Public Administration Circular No.22/99 (iv) dated 27th December, 2004 Paragraph 2.22 The Vice-Chancellor and the Registrar had used vehicles for private purposes without paying Rs.350 per month for using official vehicles for private purposes.
- (k) University Grants Commission Circular No.855 A female officer had been recruited to serve in the Institute of Emergency Health Situation and Disaster Management at a monthly salary of Rs.30,000 contrary to the Circular and salaries amounting to Rs.360,000 had been paid up to December, 2007.
- (l) Paragraph 3.4 of Procurement Guidelines Although quotations should be called for at least from 03 institutions in respect of purchases over Rs.50,000 adhering the tender procedure, quotations had not been called for in respect of goods valued at Rs.1,050, 173 in 05 instances during the year under review.

2.2.9 Transactions not supported by Adequate Authority

The following observations are made.

- (a) Language Proficiency Allowances amounting to Rs.25,016,228 had been paid from 1994 to 31st December, 2007 contrary to the letter No. PE/1/174/11 (b) dated 10th March, 1978 of the Director General of Public Enterprises.

- (b) Contributions to the Employees Provident fund and the Employees Trust Fund had been computed for Academic Allowances amounting to Rs.557,657,638 contrary to the Letter No. ප්‍ර/ආයතන/11 dated 24th August, 2001, of the Commissioner of Labour and the Circular Letter No. PD/I/NS/DL/GS/A/078 dated 18th July, 2003 of the Director General of Budget. As a result, contributions amounting to Rs.100,378,371 had been overpaid from 1997 to 31st December, 2007.
- (c) Allowances amounting to Rs.312,185 had been paid to the approved cadre of the University without obtaining the approval of the Treasury in terms of Letter No. PE1/174/1/2003 dated 29 January 2003 of the Secretary to the Treasury.

## 2.2.10 Transactions of Contentious Nature

The following observation are made :

- (a) A goods clearing institution had not handed over the goods valued at Rs.821,076 as at 31st December, 2007 and it had been agreed with that institution to recover a sum of Rs.461,753. However, this amount had been brought to account as Rs.405,732. The sum of Rs.86,889 paid by that Institution in settlement of the said amount up to the year under review had been shown in a suspense account instead of adjusting the relevant account.
- (b) Although a sum of Rs.6,434,252 had been collected to the account No. 110123900 maintained for accounting income earned from research laboratories, only a sum of Rs.2,423,091 had been credited to the relevant fund. The balance money had been credited to the Bank accounts held in the names of the Technical Officers of the said laboratories.
- (c) Whilst there was adequate funds in the Fund Account to which the sale proceeds of books published by the University lecturers are credited, the expenditure of Rs.347,300 and Rs.253,010 respectively incurred on a printing machine and stationeries relating to the above purpose had been met out of the University Fund.

## 3. Financial and Operating Review

### 3.1 Financial Review

#### 3.1.1 Financial Results.

According to the financial Statements presented, the working of the University for the year ended 31st December, 2007 had resulted in a deficit of Rs.1,938,821,433 before taking into account the Government Grant for recurrent expenditure. This deficit had been reduced to Rs.244,593,183 due to the Government Grant of Rs.1,694,228,250 received for the recurrent expenditure of Rs.2,045,183,372. The deficit for the preceding year before taking into account the Government Grant for recurrent expenditure was Rs. 2,111,681,363 and due to the Government Grant of Rs.1,533,408,400 received for recurrent expenditure, this deficit had reduced up to Rs.578,272,963.

### 3.2 Operating Review

#### 3.2.1 Performance

The following matters were observed :

- (a) According to the information furnished to audit in relation to each Faculty for 04 academic years the number of students appeared for the final year examinations, the number of students who had obtained passes or referred, and failed and the No. of students passed, failed and referred as a percentage of the number of students appeared for the examinations are given below.

- (d) Outside individuals had donated money to the University to award scholarship to the students who are having financial difficulties and the Council had decided to utilize a sum of Rs.6,656,198 equivalent to 80% of the interest expected from investing the above money for the intended purpose. A systematic programme had not been prepared to fulfill the purpose and as a result, the sum of Rs.5,607,499 equivalent to 84% which should be utilized awarding scholarships to the students for the year 2007 had not been utilized.
- (e) A sum of Rs.5,815,333 relating to 58 non - implemented researches as at 31st December, 2007 had been transferred to the Non-implemented Reseraches Account. Therefore, it is observed that the expected purposes had not been successfully fulfilled.
- (f) Out of the provisions amounting to Rs.6,299,276 made to the University in 2006 for researches, a sum of Rs.3,601,158 equivalent to 57% had not been utilized even as at 31st December, 2007.
- (g) Although the periods of 13 researches valued at Rs.1,861,450 commenced utilizing the provisions of the University during the year 2006 had been lapsed, the final reports of these researches had not been handed over even by December 2007.

### 3.2.2. Deficiencies in Contract Administration

The Following observations are made :

- (a) According to agreements in respect of 22 works relating to repairs to buildings and constructions, of the University, of which the estimated cost was Rs.56,181,596 should be completed during the years 2000 to 2004. However, items valued at Rs.35,359,094 of these contracts had not been done and had abandoned as at 31st December, 2007. Action had not been taken during the year 2006 to get those items completed and action had been taken against the contractors in terms of the agreements for non completion of the contracts and for defective works.
- (b) The Vice-Chancellor of the University had entered into an agreement with the Central Engineering Consultancy Bureau on 25th July, 2005 for awarding them the construction of a hostel at an estimated value of Rs. 150 million. The following matters were observed at an examination of this construction.
- (i) At the time of selection of a land for construction of this hostel, lands nearby New Akbar Hall of the Engineering Faculty or the Marcus Fernando Hall had been identified as suitable for the purpose. However, finally a land at Uda-Peradeniya

with no facilities and not suitable for a hostel and possibility of having earth slips had been selected. Therefore, a sum of Rs.28,221,230 had been spent on extra works of the construction.

- (ii) According to the original plan, it had been estimated to construct a concrete toilet system and it has been changed to construct the sewerage system using 27 Bio-cells on a direction given by the Vice-chancellor. However, there was no proper approval for these changes. When filling soil, after placing the Bio-cells valued at Rs.3,960,000, the cells had been cracked and therefore these had to be removed and the sewerage system had to be constructed again. Accordingly, the above payment had become a fruitless expenditure.
- (iii) According to the Report No J of the works, the Aluminum Frames used for windows were substandard. Therefore, it could not be satisfied about the durability of the windows not made up to the specifications, though a sum of Rs.10,850,918 had been spent.
- (iv) According to the estimates and the plans, 58,900 cwts of iron was required for the concrete slab and a sum of Rs.5,296,560 had been provided for the same. But, according to the vouchers, payments amounting to Rs.9,363,106 had been made for 93,011 cwts of iron. The payment in excess of the estimate was Rs. 4,066,546. However, only 83,763kgs. of iron had been used for 17 items of work, whereas the estimated quantity of iron required for these works was 125,476kgs. It was observed that this situation will be badly affected the strength of the building.

### 3.2.3 Management Inefficiencies

The following management inefficiencies were observed :

- (a) The legal ownership had not been obtained in respect of the lands at Polgolla, Dodangolla and Maha Illuppallama which had been used by the University for over a long period,
- (b) According to the lease agreement entered into with the People's Bank on 18th March 1982, the annual lease rent should be revised. But, without taking action accordingly, annual lease rent of Rs.300 had continued to be recovered since 1982,
- (c) Although an injunction had been issued in terms of Section 120(a) of the Universities Act, No.16 of 1978 and Section 3 of the Re-vesting the Ownership of the Government Lands, Act No.07 of 1979, this injunction had not been implemented from 2003 to the year under review,
- (d) Salaries amounting to Rs.231,469 paid to an officer who had obtained no pay leave from year 1997 to 2003 had not been recovered even as at 31st December 2007 and had been shown in the financial statement as a balance recoverable,
- (e) A sum of Rs.486,312 had been paid to a lecturer for preparation of designs for University buildings even though Engineering Services and Consultancy Services Centre had been established under the Faculty of Engineering for providing consultancy services for the University of Peradeniya. However, due to the defects in the above designs, the designing had been entrusted again to the State Engineering Corporation and a payment of Rs.345,000 had been paid to the Corporation. Therefore, the payment of Rs.486,312 made to the lecturer had become fruitless,
- (f) Although equipment purchased for projects should be handed over to the University, immediately after the completion of the projects, equipment to the value of Rs.815,154 purchased for 04 projects of which the research activities had been completed during the years 2005, 2006 and 2007 had not been handed over to the University even as at 31st December 2007,
- (g) Tenders had been called for, the purchase of beds and cupboards for the new hostel and the recommendation of the Technical Evaluation Committee also had been obtained for the lowest tender submitted. However, the tender had been awarded to the highest tenderer without producing valid reasons for rejecting the lowest tender. As a result the University had to suffer a loss of Rs.5,805,035. Further, the beds supplied by the tender had to be improved by spending the provisions of the University as the beds were defective and could not be used.

### 3.2.4 Idle and Underutilized Assets

The following observations are made :-

- (a) The Earth Quake Detecting Equipment valued at Japanese Yens 39,854,123 (S. L. Rs.30 Million approximately) granted by the Japan International Co-operation Agency to the Government of Sri Lanka in November 2002 had been installed in April 2003. However, this had not been in operating condition even as at 31 December 2007 due to the defects in the computer and telephone system of the equipment,
- (b) Balances of 66 Other Fund Accounts amounting to Rs.7,852,415 had remained idle for periods ranging 02 to 04 years, whilst balances of 27 accounts amounting to Rs.1,589,824 had remained idle for over 05 years,
- (c) Balances of 30 External Research Accounts amounting to Rs.4,632,767 had remained idle for periods ranging 02 to 03 years, whilst balances of 15 accounts amounting Rs.675,763 had remained idle for over 05 years.

#### 3.2.5 Corporate Plan

A corporate Plan including the vision and the objectives of the University for not less than 03 years including the year under review, had not been prepared in terms of paragraph 5.1 of the Circular No.PED 12 dated 02 June 2003 of the Director General of Public Enterprises and the Council also had not paid attention to prepare and implement such plan.

#### 3.2.6 Internal Audit

According to the approved cadre of the Internal Audit Division of the University 02 vacancies for Audit Assistants had not been filled since year 2004. By half yearly Reports and Final Progress Reports on internal audit activities that should be submitted to the Auditor General had not been submitted and therefore, the performance of Internal Audit Division could not be evaluated.

#### 3.2.7 Budgetary Control

Significant variations were observed at a comparison of estimated income and expenditure for the year under review with the actual income and expenditure thus indicating that the budget had not been made use of as an effective instrument of management control.

Deficiencies of Systems and controls observed during the course of audit were brought to the notice of the Vice-chancellor of the University from time to time Special attention is needed in respect of the following areas of control :

- (a) Receipt of income and accounting for income,
- (b) Purchases,
- (c) Contract administration,
- (d) Advances,
- (e) Fixed assests,
- (f) Stocks and inventory control,
- (g) Control over vehicles,
- (h) Maintenance of registers,
- (i) Conducting researches,
- (j) Works in progress,
- (k) Maintenance of ledger accounts.
