Competitive Examination for the Recruitment to the Post of Class III Grade II Tax Officer in the Provincial Revenue Service of the Department of Provincial Revenue of the Western Province Public Service – 2009

APPLICATIONS are called in from both male and female candidates for the vacancies existing in the Class III Grade II tax officer positions in the Provincial Revenue Service of the Western Province Public Service.

02. 2.1 According to the Public Administration Circular 06/2006(IV), monthly remuneration relevant to this post is Rs. 16,720 -10x320-11x365- 15 x 450-30,685 (Step 1 of MN-5-2006A).
- 2.2 Age Limit.– Should be below 30 years of age as at the closing date of the applications. Applicants who are already employed in the Public/Provincial Public Service are exempted from the maximum age limit mentioned above. They should forward their applications through the Heads of their Departments.
- 2.3 *Service Conditions.*– Service conditions depend on the approved Service Minute. This is a permanent position with eligibility for a pension.

04. Candidates :

- 4.4 Applicants should prove the permanent residency within the Western Province and should have at least 03 years of permanent residence within the Province as at the closing date of the application which is 2010.05.31. For this, a certificate issued by the Divisional Secretary confirming permanent residence should be forwarded.

05. *Procedure of Recruitment.*– When the number of applications received will not exceed the number of existing vacancies, recruitments shall be made subsequent to examining the qualifications required, by a selection board.
