PROVINCIAL COUNCIL (PAYMENTS OF SALARIES AND ALLOWANCE) (AMENDMENT) STATUTE No. 04 OF 2009

A Statute to further amend the Provincial Council (Payment of salaries and allowances) (Amendment) Statute No. 04 of 1989 amended by the following amending statutes No. 03 of 2000, No. 02 of 2001, No. 03 of 2002, No. 04 of 2004 and No. 01 of 2006.

The amending statute if passed by the Provincial Council of the North Western Province of the Democratic Socialist Republic of Sri Lanka, will be as follows :

Short Title.

1. This Statute may be cited as the Provincial (Payment of salaries and allowances) (Amendment) Statute No. 04 of 2009 of the Provincial Council of the North Western Province.

Amendment of
Section 2(ඉ) of the
Principal Statute.

2. (i) Sub section 2(ඉ) of the Principal Statute is hereby amended by the removal of the words "Rupees Ten Thousand" and instead the substitution of the words "A monthly allowance in agreement with the approved by the Cabinet Ministry of North Western Provincial Council and Hon. Governor of the North Western Provincial Council".

Section 2(ඊ) of the
Principal Statute.

(ii) Sub section 2(ඊ) of the Principal Statute is hereby amended by the removal of the words "Rupees Ten Thousand" and instead the substitution of the words "A monthly allowance in agreement with the approved by the Cabinet Ministry of North Western Provincial Council and Hon. Governor of the North Western Provincial Council".

Sinhala text to

3. In the event of any inconsistency between the Sinhala and Tamil text of the Statute the Sinhala version of the text shall prevail.
