Report of the Auditor General on the Financial Statements of the Public Service Provident Fund for the year ended 31st December, 2010

THE audit of financial statements of the Public Service Provident Fund for the year ended 31st December, 2010 was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 24 (1) of the Public Service Provident Fund Ordinance (Cap 621). My comments and observation on the above financial statements appear in this report.

1:2 Responsibility of the Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Generally Accepted Accounting Principles. This responsibility includes; designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

1:3 Scope of Audit and Basis of Opinion

My responsibility is to express an opinion on these financial statements based on my audit. Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards to obtain reasonable assurance as to whether the financial statements are free from material misstatements. The audit includes the examination on a test basis of evidence supporting the amounts and disclosures in financial statements and assessment of accounting policies used and significant estimates made by the management in the preparation of financial statements as well as evaluating their overall presentation. I have obtained sufficient information and explanations which to the best of my knowledge and belief were necessary for the purpose of my audit. I therefore believe that my audit provides a reasonable basis for my opinion.

2. Financial Statements

2.1 Opinion

So far as appears from my examination and to the best of information and according to the explanations given to me, I am of opinion that the Public Service Provident Fund had maintained proper accounting records for the year ended 31st December, 2010 and except for the effects on the financial statements of the matters referred to in paragraph 2:2 of this report, the financial statements have been prepared in accordance with Generally Accepted Accounting Principles and give a true and fair view of the state of affairs of the Public Service Provident Fund as at 31st December, 2010 and the financial results of its operations for the year then ended.

2:2 Comments on Financial Statements

2:2:1 Accounting Deficiencies

Even though the unpaid bonus and interest that should have been credited to the Consolidated Fund in July of the year under review amounted to Rs. 4,420,024, the Fund had credited a sum of Rs. 44,200,238. Accordingly a sum of Rs. 39,780,214 had been over credited to the Consolidated Fund and that had been shown inappropriately in the balance sheet as prepayments. Thus a sum of Rs. 364,652 had been under appropriated to the Government Bonus Contribution Account in the appropriation of the profit for the year under review.

2:2:2 Accounts Receivable and Payable

The debit and credit balances that should have been settled through the other Ministries and Departments as at the end of the year under review totalled Rs. 12,936,562 and Rs. 85,823 respectively.

2:2:3 Non-compliance with Laws, Rules and Regulations

Instances of non-compliance with the following laws, rules and regulations were observed.

Reference to Laws, Rules and Regulations

(i) Section 2 (2)

Individual accounts for each Contributor had not been maintained.

(ii) Sections 25

According to the above Sections after the close of each financial year, the Director General of Pensions should inform the Contributors the balance lying in the Contributors' accounts as at 31st December. Nevertheless, such action had not been taken in the year under review.

(iii) Sections 11 (3) (c)

Any undivided surplus remaining after the appropriation of the profit for a year should be carried forward to the ensuing financial year and made use of for the appropriation of the surplus for that year. Nevertheless, the Fund had not taken action accordingly. The undivided portion of the surplus had been transferred to a General Reserve Accounts and the balance of that accounts as at 31st December, 2010 amounted to Rs. 31,456,580.

3. Financial and Operating Review

3.1 Financial Results

According to the Financial Statements presented, the financial results for the year under review before appropriation to the members amounted to a surplus of Rs. 2,593,589,969 as compared with the corresponding surplus of Rs. 2,392,356,388, thus indicating an increase of Rs. 201,232,581 in the financial result as compared with the preceding year. It was observed that the increase of the interest income by Rs. 198,635,454 or 8.3 per cent as compared with the preceding year had been the reason for this improvement of the surplus.

3:2 Interest Percentage Declared to Members

The interest per centage declared by the Fund for the members in the year under review and the preceding 10 years had fluctuated between 11.75 per cent and 7.1 per cent. The interest per centage declared to the members in the year under review as compared with the preceding year had decreased by 0.85 per cent.

3:3 Interest Income Lost by the Fund

The Government bonus receivable from the Secretary to the Treasury had not been received by the Fund and as such the Fund had not been deprived of the interest income that could have been earned from the investment of that money. The interest income so deprived of in the year under review and the preceding year had been as followed.

According to the above observations, the investments interest income lost by the Fund in the nearest 07 years amounted to Rs. 1,214.8 million.

3:4 Utilization of Staff

The membership of the Fund by the year under review as compared with the year 2003 had improved by 40.16 per cent, but there had been no change in the number of the staff for carrying out the operations of the Fund. As such it was observed that the number of members assigned to each officer had increased. The positions with regard to the year under review and the preceding 07 years is given below.

A delay in the regular work of the Fund due to the increase in the membership to staff ratio was observed. The Director General informed that the number of staff had been increased by 08.

3:5 Payment of Benefits to Members

Out of the applications made by the members for the year 2010 for benefits, there were 3,905 applications unpaid by 31st December, 2010 due to the lack of improvement in the number of Staff and that represented 39.9 per cent of the total number of applications. The position with regard to the year under review and the preceding 05 years is given below.

According to the above data, the expected targets had been achieved in 02 instances while the expected targets had been exceeded in 02 instances. It was observed that the target for the payment of benefits to the contributions had been set unrealistically.

- (b) According to the Funds Management Analysis of the Financial Statements for the year under review, one of the 04 basic activities directed towards the objectives of the fund had been stated as the maintenance of the members' accounts in a manner to enable the communication of the and balance of the member's accounts to the members. Nevertheless, the individual accounts had not been maintained in a manner to enable the communication of the year and balances as at the end of the year under review to the members. Nevertheless, a Pilot Project in this connection had been commenced.

3:7 Management Weaknesses

According to Circulars No. 1/97 dated 31st July, 1997 and 14/2006 dated 30th October, 2006 of the Director General of Pensions, an advices on the money credited to the Fund in each month should be forwarded by the respective institutions to the Secretary of the Fund before the 15th day of the month following. Nevertheless, the progress relating to the year 2010 had been sent by the Fund to get such advices to the Fund had not reached the expected level.

4. Systems and Controls

Differences in systems and controls observed during the course of audit were brought to the notices of the Director General of Pensions from time to time. Special attention is needed in respect of the following areas of control.

- Collection of Abatement Registers
- Collection of Contributions
- Settlement of Erroneous Debit and Credit Balances
- Action on Audit Observations.

Observations of the Management Board of Public Service Provident Fund regarding the report of the Auditor General concerning the accounts of Public Service Provident Fund for the year ending 31.12.2010.

2. Comments on Financial Statements

2:2:1 Accounting Deficiencies

This surplus remained during long period and generally an amount of 15 times of the compulsory contribution should be credited to the Government bonus money. Reason for this surplus had been the delay to apply for the awards by members after the termination of membership. However, as these awards are made only to the date on which the membership terminated, the balance money kept remained in the account. The benefits of interests earned by investing the money is appropriated and credited to the government bonus money again which caused to the increase of the surplus once more.

Usually the unpaid bonus money of the awards is credited to the Consolidated Fund by the Treasury Account Summaries at the year end. At the time when this difference was traced, there was no opportunity to submit supplementary account summary for the year 2010 and it was ultimately shown as a previous payment in the final account. However this difference would be adjusted when the unpaid bonus money of the year 2011 is credited to the Consolidated Fund. These amounts figured in the accounts as this due to the unavailability of correcting the differences without adjusting with General Treasury Books.

2:2:2 Receivable and payable accounts

Despite frequent notices by letters and over the telephone to the concerned Departments and Ministries to settle the balances remained over 5 years in the erroneous debits, was not taken any action to adhere the instructions. Therefore the above issues could not rectify. However the action was taken to correct most erroneous debits of year 2010 within the year concerned.

There are no unsettled erroneous debits in year 2008, 2009, 2010 and it was already informed the authorities by letters and telephone to settle the erroneous debits remained exceeding 4 years.

2:2:3 Non-compliance with Laws, Rules and Regulations

(a) Public Service Provident Fund Ordinance (Chapter 621) Section (2) 2

1. It has been difficult to make immediate corrections to these errors due to unavailability of proper maintenance of single accounts from the beginning of the fund. However, steps have been taken to maintain single accounts under the e-pension project.

2. Section 25

We are hopeful that this issue will be solved as the facility to inform balances to the members is available under the already started pilot program of the e-pension project.

3. II (3) (b)

Agree. Noted to follow this during the forthcoming financial year.

3. Financial and operating review

3.2 Interest percentage of the members

The average contribution collection from year 1996 to year 2009 has been increased and comparing thereto the appropriated interest percentage has been decreased due to the high phase of contribution collection over the revenue earned by the interest. Though it is experienced a higher number of contribution collections, a physical money flowing process cannot be observed as the contributions credited by monthly account summaries. Therefore the investment opportunities have been lessened and on the other hand the reinvestments which made on maturity of past investments had to be done on a situation of less interest rate are also considerably affected to the decrease in the overall interest revenue. Accordingly the appropriated interest percentage also had been reduced.

3.3 The lost interest revenue of the Fund

Letters were sent to the Secretary to the Treasury informing the decrease in appropriated interest percentage due to not receipt of imprest for government bonus and to settle the account balance of the Deputy Secretary to the Treasury after 2009 and also a discussion in this regard was held with the patronage of Director General of Treasury Operations.

This was informed also to the Secretary to the Finance Ministry by latter dated 16.03.2009 but the money not received yet.

The statement that this had been happened due to lack of attempt to get remitted the necessary subscription from the Treasury is not acceptable and would like to inform that we have taken all the necessary steps in this regard. However we have not received the money yet.

3.4 Staff recourse

We have received more applications comparing to year 2003. However the number of staff in the carder has not grown. Even though the additional officers attached to this division. the number of staff has been decreased to the previous level on account of officers' retirements of each year. However at the moment we have attached additional 8 officers to mitigate the delay.

3.5 Benefit payments for members:

A huge increase in the number of applications to get benefits could observe during year 2008, 2009 and 2010 though there was no increase in the number of staff comparing thereto which cause delay in the process. To overcome this difficulty and expedite the payments, we introduced a special project by attaching 8 officers temporarily. We hope that this delay would be minimized in due course. Comparing to year 2009 the applications received have been dramatically increased by 9 times.

3.6 Operational performance:

- (a) Though we expected 8000 registrations in the fund, the membership enrolment could be done on the basis of receipt of applications only. Therefore it is difficult to achieve the expected targets as the membership registrations done on the basis of applications received.

Further it is informed that the contribution collection has been exceeded the expected amount which is about 107%. Additional money investment stepped to 90% due to pumping the money to pay benefits as the receiving applications has been exceeded the expected targets. This artificiality immersed as a result of abundance in the number of applications received for awards and the awards that made in year 2010.

- (b) We are hopeful that we can overcome this issue as the facility is available under the already initiated pilot program of the e-pension project.

3.7 Management weaknesses:

Even though the all departments and ministries were educated clalling credit notices by the circular 14/2006 dated 30.10.2006 in addition to the circular 1/97, the institutions concerned have maintained a procedure of sending a list with cheques or different manner without following the instructions in above circulars. As a result of these irresponsive conducts, the fund could not meet with the expected targets of its productive implements. Having indentified these issues the Public Service Provident Fund has introduced an instruction manual along with Circular 04/2010 dated 25.05.2010 and it is expected the fund would be achieved the progress predicted. As the success of all these actions depends on the reactions of other institutions is has been difficult to achieve the expected goals at some times.

2. Review of the Board of Management:

2.1 Objective

The objective and the purpose of the Fund, is to afford Provident Fund benefits to those Public Servants who are, not pensionable.

2.2 Functions

The main functions of the P. S. P. F. are,

- (a) To recover and credit the Fund by an amount equivalent to 8% of the monthly salaries of those who are non-pensionable and are serving in the various departments of the Island and in the foreign missions abroad.
- (b) To receive the contributions and to store, such contributions in a methodical manner.
- (c) To process and maintain individual accounts of such contributors to enable the contributors to be notified of the amount lying to their credit at the end of each financial year, and refund the benefits at the end of contributor's service.
- (d) To invest the excess money of the Fund in "Government securities" to enable the contributors to secure a higher interest and appropriate such interest, at the end of every financial year.

2.3 Performance Appraisal :

(a) Financial Results

The amount received as Compulsory contribution and Government Bonus during the year under review was Rs. 699,295,538 and Rs. 937,496,299 respectively, while the contributions received during the year 2009 was Rs. 690,149,222 and Rs. 1,041,744,092 respectively. The total income from investment of the Fund after tax was Rs. 2,601,861,541 as compared with Rs. 2,399,711,836 last year. After providing for administrative expenses of the fund amounting to Rs. 8,271,573 a sum of Rs. 2,593,589,969 was available for appropriation as interest to the contributors. The percentage of interest thus available was 11.03% as compared with the percentage of interest of 11.82% during the previous year. However, the percentage of interest rounded up to the nearest quarter being 11.00% amounting to Rs. 2,587,491,119 was appropriated and the balance amounting to Rs. 6,098,850 was transferred to the General reserve.
