## Examinations, Results of Examinations, &c.

### LIMITED COMPETITIVE EXAMINATION TO RECRUIT TO THE POST OF RURAL DEVELOPMENT OFFICER (CLASS II) IN THE NORTH CENTRAL PROVINCIAL PUBLIC SERVICE - 2011(2012)

APPLICATIONS are called from those who are in the Provincial Public Service residing in the North Central Province having the following qualifications to be recruited to fill 08 or a near number of vacancies from the date that is approved to make recruitment in accordance with the scheme of recruitment and promotion of Rural Development Officers of the North Central Provincial Public Service.

1. *Salary Scale Relevant to the Post.*- MN 5-2006A - Monthly salary will be Rs. 16,720-11x320- 11x365 -15x450 - Rs. 30,685 while first Efficiency Bar will be before step three of this salary scale *i. e.* Rs. 17,680 the second Efficiency Bar will be before step seven of this salary scale *i. e.* Rs. 18,960.

2. *Service Conditions.*- This post is permanent and pensionable. Paragraph 10-12 of Chapter 11 of the Establishment Code are relevant. If an officer, in permanent and pensionable Public Service, is selected for this appointment he will be subjected to a probationary period of one year. In case of an officer who is in the

probationary period of the Public Service he will be subjected to a probationary period of 03 years.

In addition to the regulations mentioned in the scheme of recruitment and promotion of Rural Development Officers in the North Central Provincial Public Service, all the officers recruited to this post are liable to be bound by the regulations of the Establishment Code of the Democratic Socialist Republic of Sri Lanka, departmental regulations, statutes relevant to the post and regulations and orders issued from time to time by the Government or the North Central Provincial Council.

Officers recruited are compulsorily bound to serve for 05 years in whatever part of the authority area of the North Central Provincial Council and are also subject to internal transfers.

#### 3. *Qualifications Needed.*-

Educational Qualifications :-

- A degree from a recognized university ; *or*
- Passed in 04 subjects at G. C. E. (A/L) Examination in one sitting or (03) subjects at G. C. E. (A/L) Examination under new syllabus in one sitting and having two year

diploma certificate in social work from Sri Lanka Social Service College or Community Development Diploma Certificate from the Sri Lanka University or Agriculture Diploma Certificate from the Agricultural Training College ; or

- (c) Have at least an uninterrupted experience of 07 years as a government officer or an officer in a government corporation, after having passed in four (04) subjects in one sitting at the G. C. E. (Advanced Level) Examination or in three (03) subjects in one sitting at the G. C. E. (Advanced Level) Examination under the new syllabus ;  
or

- (d) (i) Senior Course Certificate Examination with credit passes for four subjects ; or  
(ii) Possession of at least a continuous 10 year experience as a Public Officer or an Officer of a corporation, after having passed in 06 subjects in not more than two sittings including 05 subjects in one sitting with the subjects Sinhala/Tamil Language and Arithmetic/Mathematics/Applied Mathematics/Commercial Mathematics with four credit passes at the G. C. E. (Ordinary Level) Examination/National General Certificate Ordinary Level Examination.

*General Qualifications :*

- (i) Should bear an excellent character and be of sound physical health ;  
(ii) Age limit does not apply since those recruited are in Public Service ;  
(iii) Should be a citizen of Sri Lanka ;  
(iv) Should be a resident in the North Central Provincial Council authority area.

*4. Mode of Application :*

- (a) The application must be prepared by the applicant himself using both sides of A4 paper in accordance with the specimen application shown at the end of this notification. The application should be prepared giving details from No. 01 to 09 on the first page, from No. 10 to 11 on the second page and the balance on the third page.  
(b) The correctly perfected application, with recommendations of the Head of the Department you serve and the Secretary of the Ministry, should be sent under registered cover to reach the address "Secretary, Provincial Public Service Commission, North Central Province Anuradhapura" on or before 23.07.2012. The phrase, "Limited Competitive Examination to recruit to the Post of Rural Development Officer (Class II) – 2011(2012)" should be written on the top left hand corner of the envelope containing the application.

- (c) When applications are prepared, relevant details should be included clearly by the applicants' own handwriting. Applications, not in conformity with the specimen application, incomplete, in which correct particulars are not given, not forwarded before the stipulated date and which are not sent under registered cover will be rejected without giving any notice. No complaints made on loss of applications in transit or delays will be considered, if may be useful it photostat copies of the applications are retained with the applicant.

*5. Mode of Recruitment :*

- (i) Competitive examination for this will be held in Sinhala/Tamil media. Applications should prepared in the medium the applicant sits the examination. The medium applied will not be allowed to change later.  
(ii) The examination will be held only at Anuradhapura.  
(iii) *Aptitude* – Time 01 hour, marks 100, pass marks 40% (Through this question paper, it is expected to assess the candidate's numerical ability, reasoning ability and general intelligence). Questions involve short answers. Answers should be supplied to all the questions. Recruitment will be done from candidates on a priority basis who receive more than 40 marks for the written question paper.  
(iv) On examination of personal files by a committee appointed by the Commission and on confirmation that the candidate had served in a Post of a Rural Development Officer in the Provincial Rural Development Department, a maximum of 10 marks per 01 mark for each year, will be given for that period of service.  
(v) This examination will be held by the Sri Lanka Examination Department or the North Central Provincial Public Service Commission. Admission cards will be issued accordingly.  
(vi) No sooner than the admission cards are issued to the candidates, a newspaper notification to that effect will be published by the Sri Lanka Examination Department. If the admission card is not received even 2 or 3 days after such publication that fact should be brought to the notice of the Sri Lanka Examination Department as stated in the notification. It would be more appropriate if you send the certified copies of your application and payment receipt, registration post receipt and if away from Colombo, a fax number for the admission card to be sent, to the Sri Lanka Examination Department while retaining their copies with you.  
(vii) Candidates are liable to be bound by the rules and regulations imposed by the examination authority conducting this examination. If such rules and regulations are violated the decision of the Commissioner General of Examinations will be the final decision and the candidate
