#### ACCOUNTING POLICIES

#### SUMMARY OF SIGNIFICANT POLICIES

### 1. General Policies

1.1 The Balance Sheet, Statement of Income and Expenditure, changes in Net Assets and Cash flow together with Accounting Policies and Notes as at 31st December, 2011 for the year then ended, comply in all material aspects with the Sri Lanka Accounting Standards.

1.2 *Comparative Information :*

Where necessary comparative figures have been modified to conform with changes in presentation in the current year.

1.3 *Valuation of Assets :*

1.3.1 *Inventories :*

Inventories are valued at actual cost using First In First Out (FIFO) method.

1.3.2 *Cash Flow Statement :*

The cash flow has been prepared by using the "Indirect method".

1.3.3 *Property, Plant and Equipment :*

(a) *Cost and Valuation –*

All Property, Plant and Equipment are recorded at cost and are stated at historical cost less depreciation. Land value is recorded as per the Valuation Report obtained from valuation Department. However valuation of some building is pending.

(b) *Depreciation :*

Provision for depreciation is calculated on all Property, Plant and Equipment, other than free hold land, in order to write off the cost and/or valuation over the estimated economic life of such assets. Depreciation is providing in accordance with Sri Lanka Accounting Standards.

### 02. Liabilities and Provisions :

2.1 All known liabilities have been accounted for in preparing the Financial Statements

2.2 *Retirement benefit plan-Gratuity :*

Provision for gratuity was made in accordance with gratuity Act, No. 12 of 1983 and SLAS 16. The Gratuity liability is not externally funded nor actually valued. The Gratuity fund Account is shown under Non-current liabilities in the balance sheet, based on half month salary as of the last month of the financial year of all employees for each completed year of service, commencing from the first year of service.



### 2.3 Income Statement :

#### 2.3.1 Revenue Recognition :

The Revenue generated through internal sources, Government grant received and the expenditure were recorded on accrual basis. The Government grant released by the Public Enterprises Division was taken into account.

#### 2.3.2 Expenditure Recognition :

The expenditure has been analyzed by projects/objects and by department and classified according to the different expenditure headings based on guidelines given by the University Grants Commission and the Common Format Reporting System.
