#### 01. Service Conditions. –

- 1.1 This post is permanent and pensionable. Contributions must be made to Widows' and Orphans'/Widowers' and Orphans' Pension Scheme.
- 1.2 Selected candidates will be appointed subjecting to a probation period of three years. If any candidate already holds a permanent post in Public or Provincial Public Service is selected he/she will be appointed on one year acting basis.

- 1.3 Should function according to the provisions of Establishment Code of Democratic Socialist Republic of Sri Lanka, Financial Regulations, Public Servants' Civil Procedure Code of Western Province, Financial Rules of Western Province, regulations or orders enacted by the Hon. Governor of Western Province from time to time, other regulations or orders enacted by the Provincial Public Service Commission of Western Province from time to time and orders of the Ministries and Departments.
- 1.4 Should be subjected to provisions enacted by P.A.C. 07/2007 with regard to implementation of National Language Policy and provision to be enacted in the future.

02. *Method of forwarding Applications* .– Applicants should prepare their applications according to the specimen application form given below in an A4 size paper using both sides and should fill it by the applicant accurately, clearly and strictly in the medium in which he is supposed to sit for the examination.

Applicants employed in the public service or provincial public service should send their application forms through their Heads of Department.

Uncompleted applications and applications received after the closing date will be rejected. Applicants should bear the responsibility on that regard.

03. *Recruitment procedure*.– Selections will be made to the number of vacancies to be filled checking qualifications by a structured interview according to the applications received from applicants who have completed qualifications. If applications more than the number of vacancies will be received from qualified applicants Selections will be made to the relevant number of vacancies checking qualifications by a structured interview on the order of merits according to the results of a written examination conducted by the authority of appointment or an institution delegated power by the authority of appointment only for the posts from number 01 to 06.

04. *Structured Interview* .– A structured interview will be held for the posts from number 01 to 06. These posts are directly connected to behavioral control of children that should be functioned very sensitively. Qualified applicants from the applicants faced for the written examination will be called for the structured interview. Only the applicants who score total marks of higher level determined adequate by the authority of appointment will be called for the structured interview. If there are a sufficient number of applicants who complete above qualifications, a two-fold as the number of vacancies will be called for the structured examination. The marks obtained by the applicant in the written examination will not be given to the Board of structured interview. Selections will be made according to the marks obtained by the examination and the marks given by asking specific questions on the capability of delivering duties relevant for this post by a Board of expert not less than three persons with experience and profound knowledge on children’s rights, psychological conditions and protection of children appointed by the authority of appointment.

05. *Interview* .–An interview will be held for the posts from number 07 to number 11. Selections will be made according to the marks obtained by the examination and the marks given by an interview board comprising of not less than three persons appointed by the authority of appointment asking specific questions from the applicant on his ability of delivering duties relevant for the post.

06. The examination fee is Rs. 350/-. The receipt obtained on payment of this examination fee as crediting to Provincial Revenue Head 20-03-02-99 to the nearest Divisional Secretariat should be annexed and forwarded with the application form. Neither receipts obtained by paying the fee to other institutions nor money orders other than the receipts obtained by paying the fee in this method will be accepted, and the full amount or a part of the examination fee will not be refunded to the applicants who does not sit for the examination or remove the application due to whatever reason and the applicants who are revealed to be ineligible to sit for the examination. Further the fees paid for this examination cannot be accredited to another examination.

07. If the candidates sit for this examination breach laws and rules enacted by the Ministry of Health Indigenous Medicine, Social Welfare, Women’s Affairs, Probation & Child Care Services and Council Affairs of Western Province they will be subjected to any punishment enacted by the Ministry of Health Indigenous Medicine, Social Welfare, Women’s Affairs, Probation & Child Care Services and Council Affairs of Western Province.

08.
