- Should have passed General Certificate of Education (Ordinary Level) or National Certificate of General Education (Ordinary Level) minimum 6 subjects including Sinhala or Tamil Language, in not more than two sittings.
- Only the Sanitary Labourers completing the prescribed syllabus for Grade 8 (Year 9) is sufficient.

05. *Competencies/Efficiencies for Electricians :*

- Should be obtained the certificate Level 02 (NVQ 2) or Level 03 (NVQ 3) from the National Vocational Qualification, related to the Electrician profession ; or
- Should be followed a course not less than one year and obtained the certificate from the Department of Technical Education and Training (DTET) relating the Electrician profession ; or
- Should have certificate following a course related to the Electrician profession not less than one year in the National Youth Services Council (NYSC) ; or
