- (i) Applicants other than applied for the post of Driver, shall face an interview and the selection will be made after verification of qualifications.
- (ii) Applicants selected on the result of highest marks scored in a written examination for those who applied for the post of Driver, scheduled to face a professional competency trade test and the highest marks scorer from that shall be selected on the basis of merit order among the applicants who possess all required qualifications.

- (iv) Those who hold permanent posts in the Central Province Public Service will be subjected only one year testing period.

04. *Other General Terms :*

- (ii) Applicant should be a citizen of Sri Lanka by descent or by registration.

The appointment will be cancelled if the medical examination reveals the unfitness of physical condition.
- (iv) Should not have been convicted by a Court of Law under Penal Code.

- (vi) Should not be dismissed from the Government or Local Government service and should not a person retired under Public Administration Circular No. 44/90.

- (vii) Applicants presently employed in Government or Provincial Public Service should not be subjected to any punishment (except warnings) within 05 years period immediate to the closing date of application and should count a satisfactory service earning all increments in due periods. Should make further contribution to the Widows' Pension Scheme.
