NOTIFICATION MADE UNDER STATE LAND REGULATION No.21 (2)

IT is hereby notified that for the Residential Purpose, Mrs. Indhu Inoka Meewalaarachchi has requested on lease a state land containing in extent about 0.0253 Ha. out of extent marked lot C as depicted in the in plan No NU/NEW/2003/809 and situated in the Village of Hawaheliya belongs to the Grama Niladhari Division of Sandhathenna coming within the area of authority of Nuwara Eliya Divisional Secretariat in the District of Nuwara Eliya.

02. Given below are the boundaries of the land requested :-

- On the North by* : Neshbi Watta ;
On the East by : Neshbi Watta ;
On the South by : Lot No. A & Neshbi Watta ;
On the West by : Lot No. A & Neshbi Watta.

03. The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions and the following conditions :-

- (a) *Terms of the Lease.*- Thirty (30) Years (15.06.1995 on wards);
The Annual Rent of the Lease.- 4% of the undeveloped value of the land as per valuation of the Chief Valuer for the year from 1995 ;
Penalty .- Treble 4% of the developed value of the land;
- (b) The lessees must, within one year of the commencement of the lease, develop the said land in such a manner as to captivate the mind of the Divisional Secretary ;
- (c) The lessees must not use this land for any purpose other than for the Residential purpose;

- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary and by other institutions;
- (e) The buildings constructed must be maintained in a proper state of repair ;
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained action will be taken to terminate the lease ;
- (g) Permission will not be given for any other sub- leasing or transfer, other than transferring within the family or sub- leasing or transferring to accomplish the purpose of this lease Bond until the expiry of 05 years from 17.07.2013. A grant could claimed for this lease bond after the expiry of 05 years from 17.07.2013. ;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse;
- (i) House construction activities must be completed within the time frame specified in alienating lands for house construction purposes and the failure to do so will be deemed as a lapse of the long - term lease bond and the land will have to be re-vested in the government.

04. If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
