* Garbage is not collected from business institutes which do not pay charges.

* You are liable to a spot fine within the range from Rs. 100 to Rs. 5,000 for polluting the environment by scattering garbage in places.

* You shall be liable to a fine for each breach of above provisions regarding charges to be levied.

* Payments due for the whole year may be made at once.

* Payments may also be made by cheques written in favour of the Sri Jayawardenapura Kotte Municipal Council.
