### RECRUITMENT TO THE POSTS OF AGRICULTURE INSTRUCTOR AND LIVESTOCK DEVELOPMENT INSTRUCTOR IN THE SERVICE CATEGORY OF SUPERVISORY MANAGEMENT ASSISTANT (TECHNOLOGICAL) OF CENTRAL PROVINCIAL PUBLIC SERVICE - 2014 (2)

APPLICATIONS are called from both male and female candidates who residing within Central Province and possess required qualifications specified in this notification to fill existing vacancies in Agriculture Instructor Grade III and Livestock Development Instructor Grade III in the Service category of Supervisory Management Assistant (Technological) of Central Provincial Public Service.

1. *Physical Qualifications* .– Should possess the adequate physical and mental fitness required to serve in any area of Central Province and discharge duties of the post.
2. *Other qualifications* .–
  - 2.1 Should possess a continues permanent residence for a period of not less than 03 years within Central Province by the closing date of application on 25.11.2014 (permanent residence of spouse will be considered when the applicant having married a person holding more than 03 years of permanent residence within Central Province)
  - 2.2 Candidates should be a citizen of Sri Lanka.
  - 2.3 The applicants should have an excellent character.
  - 2.4 The Applicants should have fulfilled all qualifications required for recruitment to the post by the closing date of calling applications.

7. *Mode of recruitment .–* Vacancies shall be filled on district population ratio as per P.A. Circular 15/90. Central Provincial Public Service Commission shall conduct a competitive examination and the candidates obtaining highest marks will be subjected to an interview for selection of suitable candidates. No marks will be assigned at the interview. Recruitment will be made under the merit of marks obtained in the examination by the candidates. A minimum of 40% marks should be obtained for each question paper.

8. *Conditions of recruitment .–*

- 8.1. This post is permanent and pensionable.
- 8.2. Appointment is subject to the provisions in the public P.A. circular 01/2014 issued on Implementation of Official Language Policy
- 8.3. Should serve minimum of 05 years within Central Province once you call upon appointment, not eligible to get transfer and should have serve Minimum of 03 years in the institution of your first appointment.

9. *Method of application .–*

- 9.1. A non-refundable examination fee of Rs. 600 should be credited to the Central Provincial Chief Secretary's revenue Head 20-03-02-13. This fee could be paid to any Divisional Secretary office in Central Province and the receipt issued should be firmly affixed to the application. The application without receipt will be rejected. The paid examination fee will not be refunded under any circumstances. (A photocopy of the receipt so obtained should be retained for future reference)
- 9.2. Applications should be prepared using both side of a A4 size paper, in accordance with the specimen application form at the end of this notification. Duly perfected applications should be posted under registered cover, to reach the Secretary, Central Provincial Public Service Commission, P.O. Box 114, No. 244, Katugastota Road, Kandy, on or before 25.11.2014. The caption 'Recruitment to the posts of Agriculture Instructor Grade III/ Livestock Development Instructor Grade III of Central Provincial Public Service -2014(2)' and the Code number of administration District should be indicated on the top left hand corner of the envelope enclosing the application. This paper consists of objective questions to assess the candidate's, power of logical reasoning and analysis and ability to draw sound inferences.
  02. Technological question paper (Time 03 hours, Total marks - 100)  
Consists of multiple Choice Questions and Structural Questions applicable to the post
