### INSTRUCTIONS FOR ISSUING OF MEDIA IDENTITY CARDS BY THE DEPARTMENT OF GOVERNMENT INFORMATION

DEPARTMENT of Government Information issues media identity cards with the purpose of facilitating duties and protecting the professional dignity of Sri Lankan journalists. Therefore, all heads of media institutions are kindly requested to provide this media identity card for journalists whom it is essential.

02. Additional details on issuing of Media Identity Cards, which are not included in this procedure are stated in attachment 1. Please pay your kind attention in that regard.
03. Media Identity Cards will be issued in the following manner in order to affirm their safety and to prevent them being achieved by irrelevant persons.
  - (i) Local Journalists:  
Journalists attached to a recognized media institution on permanent or on contractual basis or journalists who have served for more than six months.
  - (ii) Photographic Journalists:  
Photographic Journalists, who are serving in a recognized media institution on permanent or on contractual basis, for more than six months.
  - (iii) Website Journalists:  
Identity cards will be issued subject to a maximum of 5 Identity Cards for a website. (Website should be daily updated, allocate more space for news and current affairs, should have continuously maintained for six months and should be registered at the Ministry of Mass Media and Information.)
  - (iv) Freelance Journalists:  
Journalists who have continuously, within six months, presented more than 12 programmes/articles for a recognized print or media institution (published news items should be provided).
  - (v) Media Administrators:  
Media administrators who are directly engaged in media administration in a recognized media institution.

For media institutions, which 100-200 journalists are employed - 2 identity cards

For media institutions, which 200-300 journalists are employed - 4 identity cards

For media institutions, which more than 300 journalists are employed - 5 identity cards

- (vi) Regional Journalists:

Journalists who are appointed as Regional Journalists and who can prove to have continuously reported to a national level print and electronic media institution for six months.



(vi) Media Technicians:

Media Technicians in a recognized media institution who regularly leave the office for duties related to news and/or current affairs (especially for electronic media).

(vii) Foreign Journalists.

Permanent - Journalists who permanently serve in Sri Lankan branches of Foreign Media Institutions or who are appointed as agents of those media institutions.

Temporary - Journalists who arrive to Sri Lanka for a short or definite period to cover special occasions or to produce documentaries (in case of covering special occasions the prior approval of the relevant Sri Lankan authorities should have been obtained.)

4. Every Journalist requesting for a media identity card must provide a certified photocopy of the Identity card, which is issued by their media institution and a copy of the appointment letter. Print and Electronic media, which have a considerable sale and a considerable number of readers/spectators are considered as recognized media Institutions.

5. Applications prepared by the Department should be filled in and forwarded to the Director General of Government Information with two stamp size, colour photographs and other relevant documents mentioned herein. Media identity cards will be issued normally within the first six months of each year and on special requirements until 30th September. Application forms, which are not duly filled in, will be rejected. However, the final decision on issuing this media identity card will be made by the Director General of Government Information.

6. Media Identity cards will be issued, to national level journalists on the basis of annual renewal and to regional journalists on the basis of renewal once in two years, by the Director General of Government Information with his signature. However, a list of journalists in news and current affairs divisions who require identity cards should be forwarded by the head of the media institution or the Chief Administrative Officer for the prior approval of the Director General of Government Information.

**General Conditions**

01. A maximum of 03 Identity Cards will be issued for monthly newspapers/magazines.

02. A maximum of 02 Identity cards will be issued to Newspapers/Magazines printed once in two months.

However, media institutions related to above 01 and 02, should provide recently published 12 subsequent copies in order to prove that their publication is continuously published.

03. Head of the Institution is responsible of obtaining the Identity card of a Journalist who resigned/dismissed from

his media institution and forwarding it to this Department. Otherwise, a substitute Identity Card will not be issued.

04. To obtain an Identity card for a misplaced Identity Card, it should be complained to the police and with the police report, a request should be made by the institution he serves.

05. Media Identity cards will not be issued to Newspapers/Magazines published by institutions such as religious institutions and organizations as they do not participate in general press conferences.

06. Regarding other Government Institutions, media identity Cards will be issued only to media units established in those institutions.
