All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 10th October, 2014 should reach Government Press on or before 12.00 noon on 26th September, 2014.

AN ACT TO INCORPORATE THE "INSTITUTION OF BUILDING SERVICES ENGINEERING AND TECHNOLOGY SRI LANKA"

I, Thilanga Sumathipala, do hereby gives notice under Standing order No. 48 (1) of the Parliament of the Democratic Socialist Republic of Sri Lanka, that I proposes to introduce to Parliament a Bill entitled "An Act to incorporate the Institution of Building Services Engineering and Technology Sri Lanka".

The aim of the Bill is to incorporate the said Institution which has the following general Objects :

1. To foster and promote Building Services Engineering and Technology as a Profession in Sri Lanka safeguard the

professional status, interests, rights powers welfare and privileges of Building Services Engineers and technologists, establish a path for the professional growth of members through continuous Professional Development Programmes, introduce general standards of Professional Conduct and Practice for Building Services Engineers and Technologists and ensure the maintenance of such standards in their Professional activities, and promote the general advancement of Building Services as Science, and as a Profession;

2. to create a forum locally for Building Services Engineers and Technologists to express their opinion, share knowledge, improve presentation skills and to promote fellowship and facilitate the exchange of information and ideas on subjects of Building Services, amongst the members of the Institution, liaise with Institutions/Associations of Building Services Engineers, and Technologists in other countries and discuss with Institution, Associations, Manufacturers, Contractors and other persons of engages on Building Services Engineering and Technology on matters of common interest and to affiliate with the Chartered Institution of Building Services Engineers (CIBSE), UK and any other professional body in the world ; and
3. to hold and to conduct, supervise and control the admission, professional education and training of persons desiring to quality as Professional Building Services Engineers and Technologists, prescribe or approve courses of study for qualifying examination for membership of the Institutions, prescribe the qualifications for membership of the Institution and set guidelines for those desiring to qualify as Building Services Engineers and Technologists, liaise with Universities/ Institutions to conduct courses/programmes on "Building Services Engineering and Technology" Awarding the Membership and the status and maintaining a register of Chartered Building Services Engineers including a Register of disciplines of the members, and conduct examinations to qualify personnel as building services professionals.
