| 1. | These By - Laws may be cited as By - Laws of the Kolonnawa Urban Council relating to parking of Three - Wheelers. | Short name |
| 2. | These By - Laws shall be enacted for the purpose of regulating, controlling and levying parking charges of Three Wheelers, within the jurisdiction of the Urban council. | Long name |
| 3. | (1) there shall be a committee that shall be herein after referred to as “Control Committee” consisting of the persons referred in the schedule one in order to control the Three - Wheelers. (2) A meeting of the control committee shall be held at least for every 06 months and the special meetings of control committee shall be held at any occasion, deemed appropriate by the chairman. (3) Making necessary actions to receive the calling notification for its members prior to 04 days of the control committee meeting shall be the duty of the chairman. (4) Reports shall be maintained on the decisions taken in control committee meetings and the approval should be taken for the recommendations of the said committee. (5) The Quorum of the control committee shall be one third of its members. (6) The role mentioned in the first schedule, part II shall be the role of the control committee. | 5. | (1) No Three Wheeler shall be parked at any parking place without a valid license issued by the chairman of the council or an Officer authorized by him. (2) No Three Wheeler shall be parked in any other parking place other than a parking place prescribed in the permit issued for the Three Wheeler. (3) No Three Wheeler shall be parked at a public place awaiting hires other than in the relevant parking place. (4) No vehicle other than a motor vehicle shall be parked at any parking place. | |

6. (1) No motor vehicle or any other vehicle which is not a motor vehicle, shall be parked, in a manner of obstructing the entrance and exit of the Three Wheeler Park.
 - (2) No any other repairs should be carried out in the Three Wheeler Park other than any minor repair relating to the removal of the said Three Wheeler from the parking place.
 - (3) No Three Wheeler or any kind of motor vehicle shall be washed or allowed to wash at any parking place by any person.
 - (4) When any licensed Three Wheeler is parked in a Three Wheeler park, the owner of the Three Wheeler or a person coming to hire the Three Wheeler or mechanic who came for a minor repair to the vehicle or any other person shall not loiter in the Park in manner of disturbing the public.
 - (5) Any person shall not use liquor or poisonous drugs or behave immorally or commit any offensive act at any parking place.
 - (6) Every License holder shall display clearly his/ her license on the front glass of the Three Wheeler.
 - (7) Every Three Wheeler driver shall wear a proper and decent dress.
 - (8) Every Three Wheeler driver shall keep the Three Wheel park clean.
- Applying for obtain a license.
7. (1) Any person who intends to park a Three Wheeler in a particular parking place, an application prepared in accordance with the Third schedule, issued by the Urban Council should be submitted along with the annexure required by it.
 - (2) The applications shall be submitted only after it is duly recommended by the chairman, secretary or treasurer of relevant Three Wheel society where applications are supposed to be obtained and application signed by them on the relevant place of the application in the third schedule for a license.
 - (3) Application fee is Twenty five Rupees (Rs.25). The application fee shall be decided time to time by the Urban Council as per a resolution adopted by the Sabha and such fee shall be charged with effect from the date when such decision is published in the *gazette* or a date specified there in.
 - (4) After receiving duly completed application, a license which is properly completed under the provisions of part I of fourth schedule and part II of fourth schedule may be issued by the chairman of the Sabha or any other authorized officer within seven days.
 - (5) Unless a certain license issued under the provisions of this By - Law was cancelled, the said application will be valid -
 - I till thirtieth of June (30th of June) if it is a bi - annual license, and,
 - II till Thirty first of December (31 st of December) of relevant year if it is an annual license.
- License Fee.
8. (1) Each license issued under this By - Law shall be subjected to a charge. The license shall be issued only after paying relevant fee by the applicant after the applicant is notified that it is possible to issue a license as per the application submitted to obtain a license.
 - (2) Annual application fee is Three hundred rupees (Rs. 300) by Twenty five rupees (Rs 25) per month. The fee can be amended time to time on a resolution passed by the council under the recommendation of control committee and such amendment shall come in to operation from the date of publication of them in the *Gazette* or from a date specified in the said notification.
- Violation of By-Law.
9. (1) Violation of any provisions stipulated in this By - Law by certain license holder, that Three Wheeler can be removed temporarily from the park after reasoning out by chairman of the council or an officer authorized or a police officer and after an inquiry conducted by the control committee. Having a valid license should not be an obstruction to such order.

- (2) The owner of the Three Wheeler shall produce the valid license on demand by the chairman of council or an officer authorized.
10. In terms of section 153(2) of the Urban Council ordinance and the amendments done to it from time to time to the chapter 255 of the urban council ordinance, violation of any provisions stipulated in the By - Law is an offence and the offender shall be liable to fine not exceeding a sum of Seven Hundred Fifty Rupees (Rs.750) after being convicted in a court of law and if such violation is being repeated and after being convicted by a competent court for such violation or after a written notice is handed over by the chairman or an officer authorized, drawing attention on such violation or even after such notice, the same offence is further committed, the offender shall be liable to fine not exceeding a sum of Two Hundred and Fifty Rupees (Rs. 250) for every day of committing such offence.
11. In this By-Law, Unless the text otherwise requires,
- "Urban Council"** means Kolonnawa Urban Council incorporated under Urban Council Ordinance in chapter 255
- "Jurisdiction"** means Jurisdiction of Kolonnawa Urban Council incorporated under Urban Council ordinance in chapter 255
- "Chairman"** means the chairman of Kolonnawa Urban Council or any person who has been empowered with his power and duties.
- "Authorized Officer"** means an officer who bears a permanent post in the Urban Council and who has been empowered by the chairman in writing.
- "Police officer"** means the same interpretation as defined under section 53 of Police Ordinance.
- "Owner"** means the registered owner who hires the Three Wheeler himself or any other person who hires with the consent of the registered owner.
- "License Holder"** means any person who receives a license under this By - Law to park a Three Wheeler at any parking place.
- "Year"** means a calendar year starting from first of January (1 st of January) and ending on Thirty first of December (31 st of December)
- "Hired Three Wheeler"** means any Three Wheeler, registered under Motor Vehicle Ordinance, used to hire passengers and goods.
- "Parking Place"** means a place reserved for parking Three Wheelers by the Urban Council under second schedule of these By - Laws.
- "License"** means a license issued to park a Three Wheeler under these By-Laws.
- "Maximum Number"** means the maximum number of Three Wheelers that can be parked as determined by the Urban Council as per the Schedule two.
- "Public Place"** means a road reservation of a public road or a reservation of any channel or river or stream, or premises where public institution is situated or a land belong to the Urban Council or any place where the general public gather within the jurisdiction of the Urban Council.
- "Motor Vehicle"** means the same interpretation given under chapter 203 of the Motor Vehicle Ordinance.
- "Other Vehicle"** means the same interpretation given under chapter 203 of the Motor Vehicle Ordinance.
12. In the event of any inconsistency between the Sinhala and Tamil text of this By - Law, the Sinhala text shall prevail.

Sinhala text shall prevail of any inconsistency.

- ❖ An application that has not produced relevant details with attachments should be rejected .
- ❖ When issuing license, priority should be given to the residents closest to the Three Wheeler Park .
- ❖ When there are number of eligible applicants to receive license for a park, the date of forwarding the application should be taken in to consideration .
- ❖ License should be issued only under the name of registered vehicle owner .
- ❖ If license needs to be renewed, an application for renewal should be forwarded on or before 14 days of its invalidation .
- ❖ If the application for renewing license is forwarded not on or before 14 days of license's invalidation, the application will be treated as a new application and will be considered with all the other new applications received at that time.
