Ltd. in as much as aforesaid Kahanda Gamage Daya Shantha Kahandasumithra Karunaratne as the Director of Malabe Property Development Pvt. Ltd. is in control and management of the said

Company and accordingly, all negotiations generally and all transactions is with the Company entered in to and made by Kahanda Gamage Daya Shantha Kahandasumithre Karunaratne and the person aware of all borrowings, the fact of default and liability to pay as aforesaid Kahanda Gamage Daya Shantha Kahandasumithra Karunaratne is the actual beneficiary of the financial accommodation granted by the Hatton National Bank PLC to Malabe Property Development Pvt.
