- 1. 10% of the purchase price;
- 2. 1% Local authority charges and VAT charges on same;
- 3. Auctioneers' Commission 2.5% of the purchase price;
- 4. Cost of Advertising Charges;
- 5. Notary's Attestation fee for Condition of sale;
- 6. Clerk's and Crier's fee Rs. 1,500 and any other charge incurred for the sale.
