## Examinations, Results of Examinations, & c.,

### OPEN COMPETITIVE EXAMINATION FOR THE RECRUITMENT TO THE POST OF SMALL INDUSTRY INSTRUCTOR (GRADE III) OF THE NORTH WESTERN PROVINCIAL DEPARTMENT OF SMALL INDUSTRIES - 2015

APPLICATIONS are hereby invited from the permanent residents (male/female) of the North Western Province who have fulfilled the qualifications mentioned in this notification, for recruitment to the post of Small Industry Instructor (Grade III) of the North Western Provincial Department of Small Industries.

The number of vacancies expected to be filled from the open competitive examination :

Carpentry Instructor	05
Coir Industry Instructor	05
Pottery Instructor	01

1. It is hereby notified that this examination will be conducted in an Examination Centre set up in Kurunegala by the North Western Provincial Council Public Service Commission. The North Western Provincial Council Public Service Commission reserves the right to cancel or to postpone the examination.

#### 2. Salary Scale :—

2.1 Salary Scale applicable for this post as per the Public Administration Circular 06/2006 (iv) - MN 1/2006A is - Rs. 13,210 – 10x145 – 11x170 – 10x320 – Rs. 22,040

#### Note i :

- (a) This Salary Scale is subject to the revisions effected from time to time, Officers who are recruited to the Grade III of this post are required to pass the 1st Efficiency Bar Examination within 03 years from the date of appointment as per the scheme of recruitment. The appointees should pass the 2nd Efficiency Bar Examination within 03 years from the date of promotion to the Grade II and they should pass the 3rd Efficiency Bar Examination within 05 years from the date of promotion to the Grade I.
- (b) In terms of the Public Administration Circular 01/2014 and consequential circulars, official language competency should be obtained within 05 years from the date of appointment.

2.2 *Age Limit* .— Applicants should be above 18 years and not more than 35 years. The upper age limit is not applicable for those who are already serving in the Public Service/ Provincial Public Service.

#### 2.3 Conditions of Service :

- This post is permanent and pensionable. Selected candidates should contribute to the Widow/Widowers and Orphans Pension Scheme.
- Provisions of sub-sections 10 and 12 of the Chapter II of the Establishment Code are applicable to this post.
- Selected appointees should be committed to serve in any area of the territory of the North Western Provincial Council and they are subjected to the transfers.
- The appointees should abide by the regulations of the Establishment Code of the Democratic Socialist Republic of Sri Lanka, Financial Regulations, Departmental Orders, North Western Provincial Disciplinary Procedure Code, Provincial Financial Regulations, Scheme of Recruitment to the post of North Western Provincial Instructors, Regulations of the Government and the North Western Provincial Council already issued and will be issued from time to time.

#### 3. Educational and Professional Qualifications :—

##### 3.1 Educational Qualifications :

- (a) Should have passed Six (06) subjects in not more than two sittings of the General Certificate of Education (Ordinary Level) Examination with Credit passes for Sinhala/Tamil/English, Mathematics and two (02) other subjects.

and

- (b) Should have passed at least one subject (excluding the Common General Test) of the General Certificate of Education (Advanced Level) Examination.

##### 3.2 Professional Qualifications

- Carpentry - Should have obtained a two year Certificate in Carpentry from a Government Institute or an Institute recognized by the Government.
- Coir & Pottery - Should have undergone a training not less than 06 months at a Government Institute or an Institute recognized by the Government.

P.S. : All the candidates must fulfill all the above educational, professional and other qualifications on or before 03.08.2015.

#### 4. Other Qualifications :—

- 4.1 Should be a Sri Lankan Citizen.

- 4.2 Applicants who are sitting for the competitive examination should be permanent residents of the territory of the North Western Provincial Council for a period of 03 years to the closing date of applications. (residency should be proved at the interview by a certificate issued by the Grama Niladhari and counter signed by the Divisional Secretary)
- 4.3 Applicants should have an excellent moral character.
- 4.4 Applicants should have completed all the above qualifications on or before the date mentioned in the application notification/*Gazette Notification*.

**5. Method of Recruitment .—** Recruitment to the Post of Small Industries Advisor (Grade III) will be made on merit on the results of an examination consisting of General Knowledge and Intelligence Quotient Test of 02 hours, Theory Paper of the relevant profession of 02 hours and a Practical Test of 03 hours, conducted by the North Western Provincial Public Service Commission, after conducting an interview to ascertain the qualifications. (testing the theory knowledge and the practical knowledge for Carpentry will not be required as the certificate is awarded at national level after conducting examinations, and they will be required only to sit for the general knowledge and intelligence quotient test) 50% of the vacancies of the Small Industries Instructors will be filled through the open competitive examination, and 50% of the vacancies will be filled through the limited examination and through the primary grade recruitments of the public service. If there are no enough internal applicants, vacancies will be filled by the external applicants.

**6. Method of Examination .—** Examination will be held in Sinhala, Tamil and English Medium and the applicants are not allowed to change the Medium applied.

## Subjects

### I. General Knowledge and Intelligence quotient - (Duration - 02 hours)

This is a paper prepared to identify the general intelligence of the applicant including the knowledge on social , economic, religious and cultural sectors of Sri Lanka. (General Knowledge - 50 marks, Intelligence quotient - 50 marks, Total - 100 marks)

### II. Theory test :

A written paper of 02 hours prepared in accordance with the approved syllabus, to test the theoretical knowledge of the coir and pottery trainees.

### III. Practical Test :

Applicants mentioned above (ii) should submit a creation/ creations according to their respective fields.

#### *Practical Knowledge on Coir Industry*

Preparing estimates in the Coir Sector, designing , preparation of coir and production of items.

#### *Practical Knowledge on Pottery*

Identification of equipment and machinery of the pottery industry, drawing of designs, construction, burning and designing.

7. A sum of Rs. 500 being the examination fee should be paid to the Divisional Secretariat of the area of permanent residence or the workplace to be credited to Revenue Head 2003-02-13 of Secretary, North Western Provincial Council Public Service Commission and the receipt WPSM/2 obtained from the Divisional Secretariat should be affixed to the application. Receipts other than the receipts obtained from the Divisional Secretariat or Money Orders will not be accepted and it should be noted that the examination fee is non-refundable under any circumstance.
